Proposed Changes since April 12




- Proposed Limitation on Applicability
 - Not with Single-family, Two-family and Townhomes dwellings
 - Not in Height Districts of 50 ft or less.
- Applicability in Zones which allow Multi-family uses (subject to all other regulatory considerations and site conditions).
- Current Changes to proposed Text
 - > 7-703(B)
 - ➤ 1. Height increases pursuant to this section are not permitted for single-family, two-family, or townhouse dwellings.
 - ➤ 2. Height may not be increased pursuant to this section by more than 25 feet beyond the height otherwise permitted by this ordinance; provided, however, that no building located in any zone where the maximum allowable height is less than 45 feet or height district where the maximum allowable height is 50 feet or less may be allowed to exceed such height limit.
- Height District provisions do not change (Historic Districts including Washington Street limit is 50 feet).
- Special Use Permit still required under 7-703(B).
- Height limit addition remains at 25 feet under 7-703(B).
- Mixed income 1/3 of the additional units for affordable housing under 7-703(B).



7-703(B) Could Be Requested with Approval of Proposed Updated


