(a) Renewal of Cox Telecom License Agreement

Cox Telecom is seeking a third renewal of its telecom license agreement with the City. They want to renew the agreement on the same terms as the existing agreement except have the term be from July 1 2023 through June 30 2028.

Background:

In September 2013, City Council approved a five-year license agreement with Cox to install conduit and fiber optic cables in the City's public rights-of-ways to provide telecommunications services in the City (not cable television). Under the original agreement, as amended, Cox constructed an approximately five (5) mile fiber optic ring to provide telecommunications services primarily to healthcare facilities in the City. The license was renewed for another five years in 2019.
