



# Environmental Policy Commission





## **FY2023 EPC ANNUAL REPORT**

JULY 1, 2022 – JUNE 30, 2023

#### 1. Introduction

The Alexandria Environmental Policy Commission (EPC) was established under Chapter 4, Article M, of the City Code to "advise and make recommendations to the City Council and, when appropriate, to the Planning Commission and City Manager". This report provides a summary of EPC activities during Fiscal Year 2023.

#### 2. Who We Are

The Alexandria City Council established the EPC in 1970 to advise and make recommendations to the City Council and, where appropriate, to the Planning Commission and City Manager, on matters relating to the following:

- The Climate crisis and its effects
- Clean air:
- Land use;
- Noise pollution;
- Pesticides, herbicides and contaminants;
- Solid waste;
- Water quality and supply;
- Other matters referred to the EPC by the City and citizens; and
- Other topics relating to the conservation and protection of Alexandria's environment.

The EPC, when fully appointed consists of 13 members, including five members from the field of environmental sciences, five citizen-at-large members, one member from the field of urban planning, one member with experience in Federal or state environmental statues/regulations, and one representative from the Alexandria business community. The EPC regularly works with other organizations to further the environmental goals of the City.

During this fiscal year, the commission held hybrid meetings once a month, except in January, May, and June when the meetings were virtual. Additionally, the commission held monthly hybrid joint meetings and small working group meetings with the Planning Commission from October through December and held three joint small subgroup meetings in January. All meetings were open to the public, agendas and documents considered during the meetings as well as minutes of the meetings

Throughout the year, the staff of the Department of Transportation and Environmental Services (T&ES), Office of Environmental Quality supported the EPC. The EPC wishes to express its thanks for the support and guidance provided by City leadership and staff.

#### 3. EPC Annual Retreat

The EPC held its annual retreat in May 2023. The focus included:

- 1. A discussion from Fairfax County Office of Environment and Energy Coordination, Alexandria's Office of Climate Action, and the VA League of Conservation Voters;
- 2. A discussion and selection of EPC focus areas for next year as well as areas where EPC members felt they needed more information & understanding;
- 3. A discussion of legislative "asks;"
- 4. A review of FY24 Budget suggestions and Staff vision; and
- 5. A discussion on EPC's vision for FY25, including ranking to determine funding levels for proposed actions.

## 4. EPC Activities and Accomplishments

The following are some of the major activities and accomplishments of the commission during FY2023:

Following the EPC's 2022 Annual retreat, the EPC created a list of actions they urged the City to take using the \$2 million dollars set aside by the City Manager for the FY23 budget. This included the creation of the new Office of Climate Action (OCA) and funding for 3 full-time employees – Climate Action Officer, Communication Specialist, and EV Planner.

From October through January, the EPC held meetings and small subgroup discussions with the Planning Commission on how to update the City's entitlement process to better respond to the climate crisis and encourage the community to take advantage of tax credits/incentives from the Inflation Reduction Act and the Infrastructure Act, resulting in a joint letter to City Council. This action resulted in the OCA adding amending the Green Building Policy to the City's Long Range Planning Interdepartmental Work Program to insure adequate funding and staffing with the final policy due by June 2024.

In November following a presentation to the EPC, it submitted a letter to the Planning Commission criticizing the Consolidated Sustainability Strategy (CSS) for the Potomac River Generating Station (PRGS) project and urging them to better address the climate crisis and energy efficiency concerns before the Commission approves the project. This resulted in a significantly improved, more climate focused CSS submission in February with approval by the PC and City Council.

In November, the commission sent a letter to the City Manager detailing FY2024 budget recommendations with a focus on how the city and community can take advantage of the federal

funds and programs emanating from the Inflation Reduction Act of 2022.

In February, the EPC and Planning Commission submitted a joint letter to City Council to address their concerns with the City's draft Energy & Climate Change Action Plan.

In March, the EPC wrote a letter of support for the U.S. Department of Transportation's 2022 Low or No Emission Vehicle & Bus and Bus Facilities discretionary grant application, which assisted in the City receiving grant funding.

In March, the EPC wrote a letter of support for the On-route electric Transit bus Opportunity Chargers project that supports the transition towards 100% zero emissions buses in the City of Alexandria.

In April, the EPC wrote a letter of strong support for the City's 2023 U.S. Department of Transportation's Charging and Fueling Infrastructure Discretionary Grant Program.
