4. Broadband Expansion: Municipal Fiber Network Update (Steve Chozick)

- 30 miles of conduit completed, 2.82 miles to be completed.
- 17 miles of fiber pulled, 17 miles to be completed.
- SD: Where is the network management pieces housed? SC: In City facilities.
- CR: Any thoughts on use of the second conduit at this point? VP: We are looking at public/private partnerships with the CMO and advisory groups on how to best leverage it.
- SD: Are there out-of-band links for network management? VP: No, they will rely on fiber.
- System acceptance estimated August 2025, system go-live estimated August 2026
- Conversation about the second conduit.

5. Subcommittee Working Plans

- (a) Digital Equity Committee
 - Invite broadband providers to give them an update on where they are at currently with their construction projects within the City.
 - ACP may be going away, find out what the providers are doing with the public sector to fill the void.

(b) Open Data Committee

- Memo, currently with City Attorney's office, to go to City Council to direct the City Manager's Office to have his staff identify opportunities to make data more available.
- We can work on identifying strategic data sets, how to make them available.

(c) AI Committee

- JC: Working to find someone from the State to talk with us about State initiatives around AI.

- (a) Cybersecurity Awareness Event
 - If we want to have a similar event this year we should start planning within the next month. We can discuss this at next month's meeting.
 - CR: what are we trying to do? RA: It can be around Cybersecurity, it can be something different. It could possibly be an AI talk, or an AI talk in place of our October meeting. Any/all ideas are welcomed.
 - Discussion about possible state legislation around AI.
 - SM: At the next meeting we can present possible use cases/proof-of-concept around AI and City data.
