City Council Hearings: Applicants should always call the City Clerk’s office to confirm City Council hearing dates. THE CITY COUNCIL HEARING SCHEDULE IS SUBJECT TO CHANGE.

Filing Deadlines: All required application materials must be received by the filing deadline. Incomplete applications will not be accepted after a filing deadline unless an extension has been granted by staff. Projects involving complex analysis, extensive research and unresolved issues may require additional processing time and deferral to a new hearing date.

Noticing: It is the applicant’s responsibility to send written notice to adjoining property owners in accordance with the scheduled timelines.
