In accordance with the requirements of Part II.B.1 of the MS4 General Permit dated November 1, 2018, the DEQ Northern Regional Office (DEQ-NRO) received the updated local TMDL action plans for the City of Alexandria on May 1, 2020 and additional information on April 13, 2022. DEQ-NRO has completed the review of the following local TMDL action plans applicable to the City of Alexandria and finds them acceptable:

- Tidal Potomac and Anacostia River Watershed PCB TMDL Action Plan addressing the TMDL approved by EPA on October 31, 2007 and the SWCB on April 11, 2008.
- Non-Tidal Four Mile Run Watershed Fecal Coliform TMDL Action Plan addressing the TMDL approved by EPA on May 31, 2002 and the SWCB on June 17, 2004.
- Hunting Creek, Cameron Run, and Holmes Run *E. coli* TMDL Action Plan addressing the TMDL approved by EPA on November 10, 2010 and the SWCB on August 4, 2011.
- Tidal Four Mile Run Watershed *E. coli* TMDL Action Plan addressing the TMDL approved by EPA on June 4, 2010 and the SWCB on September 30, 2010.
