St. Martin de Porres Senior Center Report for April COA Meeting 2022

We remain hopeful and encouraged that the transmission of COVID-19 Omicron's community transmission is low and the incidence to the virus continues to decline along with hospital admissions as well. We have now been open for a month and continue to screen the seniors prior to coming to the center. We continue to partner with the Alexandria Health Department (AHD) and continue daily health screening and maintaining COVID-19 precautions. So, we notified all our seniors, volunteers, and families about our reopening plans. Naturally we remind everyone to continue safe practices wearing an approved facial covering, physical distancing, hand hygiene and remaining home when ill. All classes are in person with one to two exercise classes offered virtually. Our average daily census ranges from 12-16 seniors who participate in ESOL, cognitive and physical exercises, trivia, nutrition, and cooking classes. We returned to offering weekly shopping trips, Walking Fit, and SAIL exercise classes at the Patrick Henry Recreation center twice a week. These activities helped the overall wellbeing for the seniors as they were able to participate in activities with their friends.

- The following activities and wellness checks continued throughout March.
- We continue to do outreach/wellness calls for the seniors meeting basic needs delivering supplies as needed to seniors home bound. The seniors report doing well and appreciated shopping and exercise opportunities.
- Food and Fun with Chef Phillipe cooking healthy food presentations
- trivia, puzzles, crossword puzzles, crafts, sudoku and blood pressure checks and various card games as well as group team games like basketball and Target Toss
- Continued partnership with Charles Houston Senior Center and Alexandria Day Care Center virtual trivia, brain teasers, AFE exercise classes and arts and crafts classes.
- Two seniors received their COVID-19 booster vaccine. We continue to be available to assist seniors get their booster and answer questions.
- Hybrid exercise programs such as Arthritis Foundation, Line Dancing and both in person and Zoom SAIL exercise classes.
- Senior Shopping Trips: weekly trips to Walmart, Landmark Plaza and Target
- Walking: weekly around the center and past the PHRC
- SMDP senior center and AHD consult at a minimum of weekly discussing trends and status of Omicron in the local area, SMdP is closely aligned with ALX Moving Forward. We are coordinating with AHD on scheduling the second COVID-19 booster jab. We keep DAAS informed as well.
- We coordinate with seniors who need food and assistance with utility and rent assistance through Alive, Christ House and DCHS.

The Senior Center at Charles Houston March Report for April 2022 Meeting

March started with fitness and nutrition as top priorities for Senior Center participants. Our bi-weekly walks continue to remain popular and well attended. Twenty-two participants were also able to enjoy a trip to Washington DC to see the Cherry Blossoms at the peak of their bloom.

Other notable activities and events during February include:

- Wellness/Informative Wednesday Presentation Chef Philippe cooking demo Featured three types of ways to prepare asparagus. Participants were engaged and eager to try this recipe at home.
- Weekly Thursday Shopping Trip Trips to local area markets and grocery stores, including Walmart, Dollar Tree, Roses, and the Dutch Amish Market to enable participants to purchase food, medical supplies, and essential household items.
- Weekly Walking Cub We continue our walks twice weekly at the Pentagon city Mall. Participants have downloaded a health app on their phones to track their daily steps.
- Arthritis Exercise Class Participants enjoyed a virtual exercise class over Zoom twice during the month. The Center has a monthly average of eleven duplicated participants in the exercise class.
- Goody Bag Distribution Staff did not distribute goody bags to participants this month.
- Women's History Celebration for eighteen participants with the health department's approval based on all Covid protocols they suggested. CH staff followed all guidelines and provided a safe environment for participants. Six participants shared a reflection and celebrated the women that have made significant contributions to society.

Staff continues to provide weekly wellness telephone checks, weekly teleconferences & zoom virtual activities. Virtual activities include Bingo and cognitive/brain teaser exercises (i.e., scavenger hunt, geography, general and television trivia, word search, word scramble, and rebus puzzles). For the month of March, we included Woman's History activities and information on healthy eating.

The Center is slated to reopen in April for in person activities. Staff will have two groups that will alternate days of participation. Staff are busy prepping all areas of service to provide participants a safe and fun environment to resume planned pre-pandemic activities.





<u>Senior Consumers</u>. Renewed focus is on adding businesses to the Silver Service Card program. Committee members are encouraged to get involved. Pat Miller and Mary Lee will do outreach in Del Ray the afternoon of 3/14.

Senior Employment. Goal is to help seniors find employment and to encourage businesses to hire. Evelyn Quiles is managing the Work Based Learning Initiative in addition to her responsibilities as Senior specialist. 33 residents have been enrolled in the program, five are 50+. Interviews are underway for the new WDC Director, and they are also interviewing for three open employment specialist positions. This has delayed scheduling of a resume workshop by Annabelle and Sylvia, which may happen in April to coincide with the kickoff of their Senior Entrepreneur non-profit.

<u>Seniors as Entrepreneurs</u>. Website is being finalized and plans underway for an event on 4/19 from 2-3pm for businesses and organizations who serve seniors who may be interested in the opportunity. Sylvia and Annabelle will work with WDC to confirm location and to assist with promotion.

<u>SNAP for Seniors</u>. The Elderly Simplified Application is effective 3/1/22. It is an abbreviated form and the certification for seniors is extended. SSA now has 10 SNAP clients in the Groceries to Go program and new DAAS caseworks are making more referrals.

<u>Senior Ambassadors</u> First Spanish language training was held on 2/23 and Margaret Shetler will be providing weekly updates in Spanish. SSA has reached out to everyone who has been trained to verify their continued engagement.

<u>Livable Community Plan</u> Jane King is preparing final report for AARP and will send information to Evelyn so that she may update goals, accomplishments and outcomes from a WDC perspective. She will be presenting at the SSA March 17 Speaker Series event, to highlight achievements of the 2018-2021 plan and get input on goals for the next three years.

<u>Senior Employment</u>. Goal is to help seniors find employment and to encourage businesses to hire. Evelyn Quiles is managing the Work Based Learning Initiative in addition to her responsibilities as Senior specialist. Announcements for the new WDC Director, and three open employment specialist positions are expected soon. Many older adults seeking help from WDC are experiencing lack of confidence, which impacts their success in getting hired. WDC is developing workshops geared towards this issue, wardrobe updates, and peer support groups.

<u>Seniors as Entrepreneurs</u>. Website is still being finalized and plans were delayed for kickoof event, now planned for 5/19 at Beatley Library. They have connected with the Small Business Development Center for support. Mary Lee will provide a congratulatory message for the website nlt 4/8.

<u>SNAP for Seniors</u> SSA has 10 SNAP clients in the Groceries to Go program and new DAAS caseworkers are making more referrals. Application for a grant to support SNAP outreach will be submitted. Grocery program hopes to find volunteers who speak Spanish and Amharic to expand outreach to those communities.

<u>Senior Ambassadors</u> First Spanish language training was held on 2/23 and AARP will be hosting a presentation in Spanish for those ambassadors later this month.

<u>Livable Community Plan</u> Jane King is preparing final report for AARP and will schedule time to review WDC information with Evelyn so that she may update goals, accomplishments and outcomes from a WDC perspective.
