Chair Report

March 2022

Commissioners,

The last time the Commission for the Arts met in person was at the Lee Center in February 2020. Two years later we will finally return. I look forward to finally seeing you again/meeting you! So much has happened over these last two years. I took over as chair during the fall of 2020, which means this will be my first time running the meeting in person. You may not know this, but I'm usually writing copious notes on yellow legal pad through all of our meetings. This is happening off-camera, somewhere in the blank void/green screen of my home office. I also sometimes draw people's heads, a practice that is far more fun in person than through Zoom.

Our agenda for this month includes approving the concept for the Old Town North Public Art Task Force, appointing community stakeholders for the Annual Workplan and TFAC Public Art Task Force, and a "Mini" orientation on grants. Additionally, Gayle Converse and Chris Kurowski met with Councilmember John Chapman and I met with the head of ACPS Arts, Meagan Carrick, so the updates section of the meeting will be longer than usual.

If this is your first time going to the Lee Center, and you are in good company, I want to help you with directions. The Lee Center is located at 1108 Jefferson Street, Alexandria, VA 22314. Give yourself extra time to arrive, as rush hour traffic on Duke and South Patrick can significantly slow things down. The Lee Center is in the southwest quadrant of Old Town. If the Old Town gird is notorious for having a handful of gateways that can bottleneck, the southwest is that same issue in miniature. If you are coming from the west, take Duke and turn right onto South Patrick and then South Henry. If you are coming from the north or south, turn east onto Gibbon. If you are coming from the Waterfront in the east take Gibbon, as well.




Figure 1 - Map of Southwest Old Town




Figure 2 - Map of Lee Center
