TASK 2 - OPEN SPACE METRICS - Ana Vicinanzo (RPCA)

(Evaluate and recommend methods of pursuing new publicly accessible open space)

- Ana Vicinanzo presented draft document detailing metrics and key performance indicators for measuring park accessibility, useability, design, and equity.
- Ana Vicinanzo presented maps detailing park pressure and heat vulnerability.

<u>Committee Discussion</u> - Issues and concerns highlighted:

• ISSUE: APPLICABILITY OF METRICS

- o How will these metrics be used?
 - A: They will be used to evaluate and determine how open space should be used in the City, per Task 2, beyond just acreage of open space per 1,000 residents. These metrics will allow the City to establish a baseline to measure progress toward the goals outlined in Task 2.

• ISSUE: EQUITY AND DESIGN - IMPLEMENTATION WHEN A GAP IS IDENTIFIED

- o How will the City proceed after a gap in equity and/or design has been identified?
 - A: City could allocate funding, volunteer efforts, and/or developer contributions to parks and areas that score low on equity and design.
- How will the City proceed after a gap has been identified but nothing can be done to improve upon this gap?
- o What actions are triggered when gaps are identified?

• ISSUE: EVALUATION AND SIMPLIFICATION OF DESIGN CRITERIA

- O Not all parks are designed to meet all the design criteria. Will parks that can't meet this criteria be forced to meet these criteria, even if they weren't designed for that certain criterion's purpose?
- o Parks need to be evaluated based on their type and intended purpose.
- The Design Criteria may be subjective depending on who is conducting the evaluation. Who will be conducting the evaluation?
- Will these design criteria homogenize all of the parks and take away their uniqueness?
- Will this Design Criteria be applied to publicly accessible private space? If so, how will the Design Criteria be applied to these spaces?
 - A: At this moment in the process, it is uncertain how the Design Criteria will be applied to these spaces, but the City plans for private land owners and developers to use the Design Criteria when providing such open space.
