Flood Action Progress Report: Schedule and Large Projects

- Master baseline schedule:
 - All Tier 1 projects are on schedule
- Large capacity projects
 - Commonwealth/ E. Glebe & Commonwealth & Ashby (est. \$50M) **design contract awarded to Jacobs**
 - Hooffs Run Culvert Bypass (est. \$60M) **in price negotiations for design**
- Combined sewer system (CSS) area projects
 - Pitt & Gibbon (\$11.5M) **underway**
 - Nethergate (\$5M) **underway**

Flood Action Progress Report: Spot Improvement Projects

On Schedule: 34 Projects Identified (est. \$12.45M)

- 15 Projects In Motion (\$8.29M)
 - 5 under planning (\$3.19M)
 - 9 under design (\$4.61M)
 - 1 under construction (\$20K)
- 5 Projects Complete (\$465K)

Flood Action Progress Report: Grants

State grant funding

- CFPF Round 1&2 Awards to Date: \$5.5M (*includes \$3.2M for Waterfront*)
- CFPF Round 3: 2 applications 4/8/2022 with award letters 9/30/2022
 - Mt. Vernon Dual Culvert Replacement and Upsize: \$1.25M
 - Inlet Program: \$764,000

Federal Funding: Flash Flooding Capital Projects

- ARPA: \$1,900,000 for Hume Avenue Bypass and Mt. Vernon Cul-De-Sac Drainage (construction)
- FY22 Community Program Funding/HUD: \$420,000 for Clifford/Fulton/Manning
- FY23 CPF/HUD Appropriation Request: \$1,120,000 for Notabene/Four Mile Rds.

City's Flood Mitigation Pilot Grant Program

- 206 applications submitted / 200 have been paid out via check
- \$659,220.09 reimbursed to date
- \$769,000 FY 2023 approved funding
- Multifamily participation is under investigation; expected early FY23

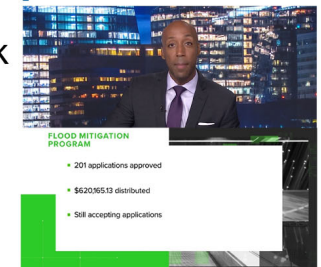
124.3% increase in Flood Action Alexandria newsletter subscribers from Dec. 2021 to Sept. 2022

Launched **Project Dashboard** to track progress of 35 active and 7 future flood mitigation projects

Reporters have done **12 stories** on different parts of the Flood Action Alexandria program since August. Stories touch on project acceleration, grants used in flood mitigation work and the manhole insert project. News outlets include: ALX Now, AlexTimes, WUSA 9, WJLA, Fox 5, NBC 4, DC News Now and WAMU 88.5. Staff will continue working with reporters to share information and updates.

Themes

- 1. Based on our current knowledge, the overall size of the Stormwater CIP seems appropriate (with many caveats).**
- 2. Based on the Committee's cursory analysis, the CIP appears to be allocated to the most flood-prone areas in the right proportions.**
- 3. The City's communication efforts regarding Flood Action are becoming effective and should be continued.**
- 4. The committee recognizes that the City's Stormwater Program is in its early stages -- actual expenditures on projects has not yet matched the 4-fold increase in the CIP. The Committee will continue to focus on the ratio of actual expenditures to planned CIP budgets in annual reports to Council.**
- 5. Kudos to Council and City staff in creating and supporting the Ad Hoc Committee – but there is significant work ahead of us as the Stormwater Program evolves and the big projects get underway.**
