EXECUTIVE SUMMARY

BACKGROUND

In April 2021, the Alexandria City Council and the School Board of Alexandria City Public Schools approved and endorsed the City's Children and Youth Community Plan (CYCP) 2025. The CYCP is a roadmap for how our community will work together to create the conditions for all young people to thrive in Alexandria. We know that our community is stronger when all young people can realize their potential. The image on the next page is the Strategy Map for the CYCP 2025. It provides a high-level snapshot of the CYCP 2025 vision, goals, objectives, and strategies.

MONITORING THE PLAN'S PROGRESS

Each Strategy in this Plan is connected to an Action Plan. Tactic Owners, who are responsible for implementing the action steps, report their progress to their Strategy's Champion, a specific person or entity who is responsible for coordinating the Plan's implementation. Champions report progress to the Children and Youth Community Plan Coordinator who then reports that progress to the general public in the form of these Progress Reports and the [CYCP Report Cards](#). Tactic Owners and Champions are also encouraged to use the CYCP Scorecard - an online tool that helps organizations evaluate their performance, measure our impact, and report our progress with the community. OVERALL PROGRESS

The Plan is made up of 30 action plans containing 44 strategies and 169 action steps. Information on the progress of each of these actions was collected from over 40 Tactic Owners. Some Tactic Owners were able to provide many details on their efforts, while others were limited with the amount of information they could provide at this time. Based on the information that was provided, it was determined that approximately 78% of the Plan's actions are either in progress or have been fully implemented. However, there is about six percent of the Plan's progress that is still being determined. Eleven percent of the Plan's actions have not begun their implementation yet. Finally, because this Plan is considered a living document and the actions it prescribed in the spring of 2021 were a starting place, it has been determined that about five percent of the actions need to be revised or removed to meet the needs of Alexandria's young people.

PERFORMANCE MEASUREMENTS

- **30** Scorecards created

How well did we do it?

- **38%** of Tactic Owners attend the Work Group Meetings
- **24%** Tactic Owner Turnover rate
- **43%** of Scorecards in use
- **9%** of actions without tactic owners

Is anyone better off?

- **62%** of Scorecard users report on the progress of their results

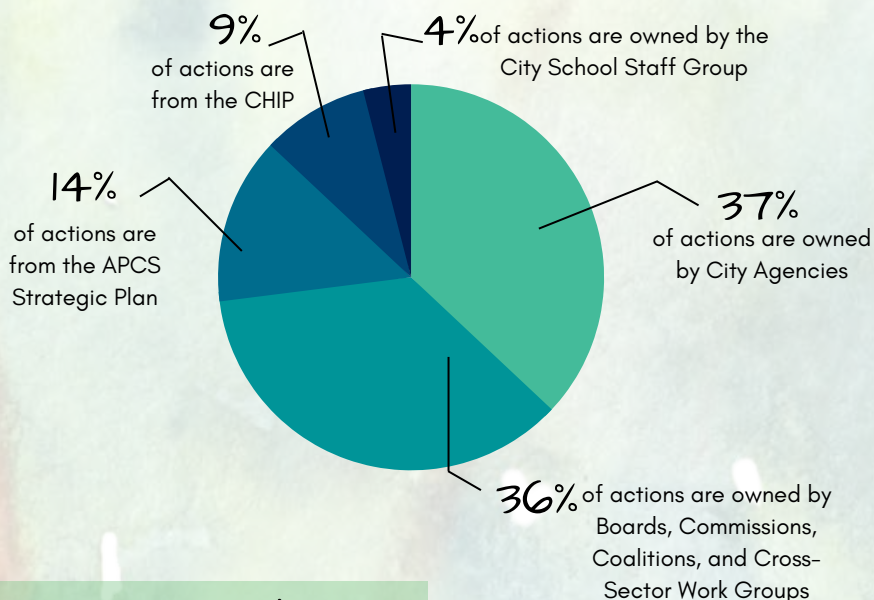

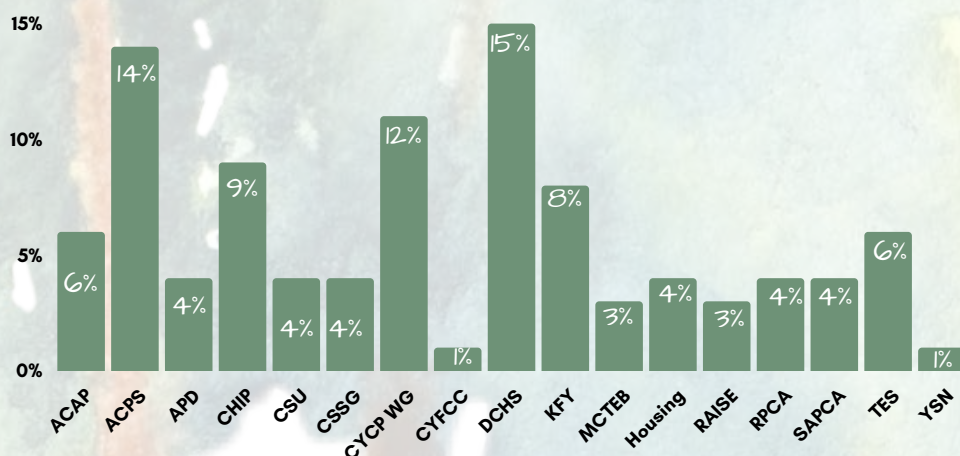

The **Children and Youth Community Plan 2025** is connected to many City-wide plans that aim to improve outcomes among Alexandria's residents, including the Alexandria City Public Schools (ACPS) **Equity for All Strategic Plan 2025** and the Alexandria Health Department (AHD) and the Partnership for a Healthier Alexandria **Community Health Improvement Plan 2025 (CHIP)**.

In one of the first major plan alignment efforts of the city, the leadership of these organizations established a Unified Implementation Team to jointly develop the three plans in areas where the goals and outcomes overlapped. 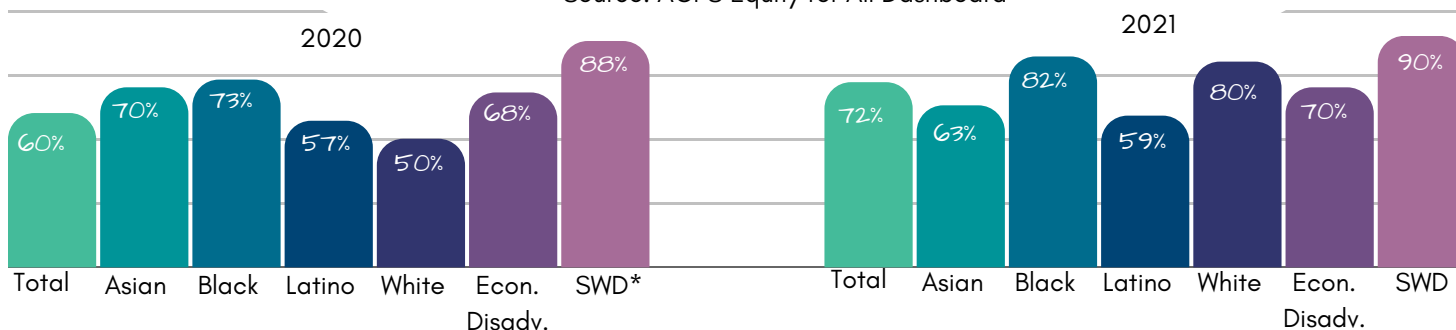

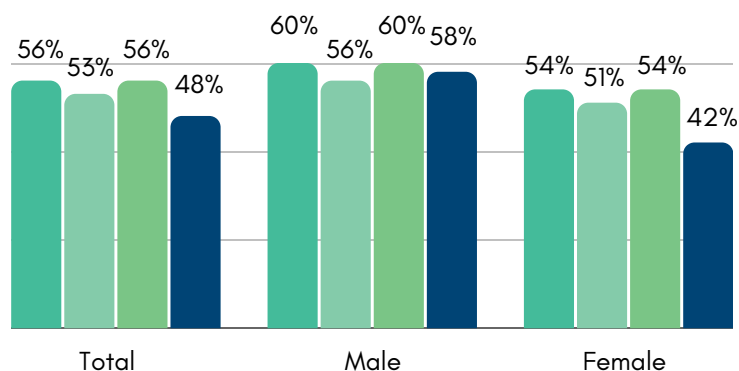

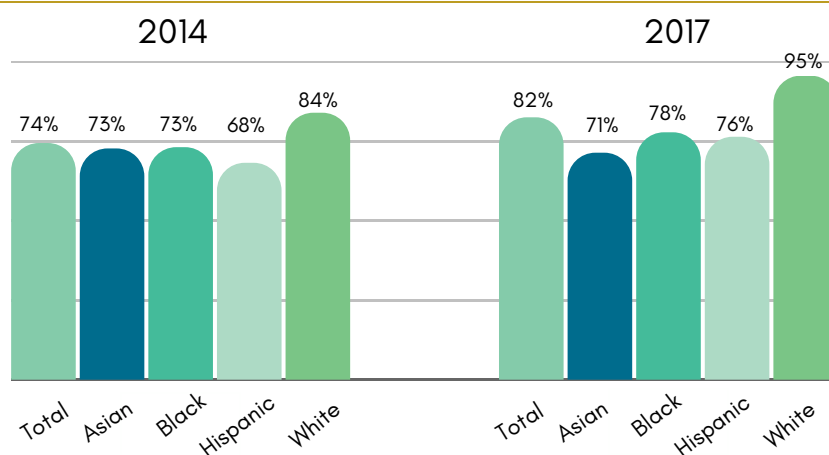

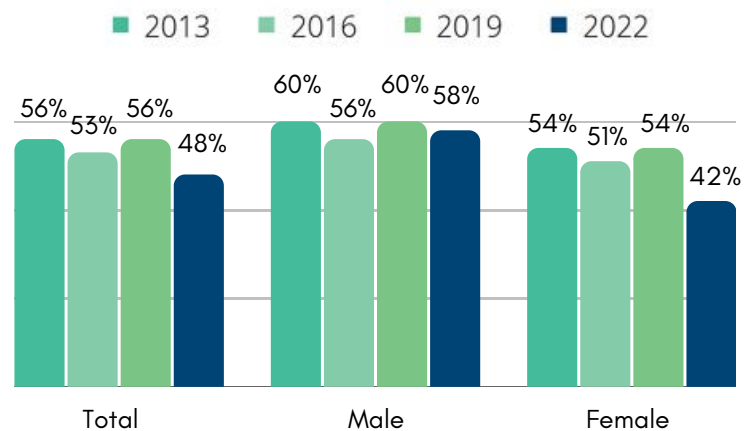

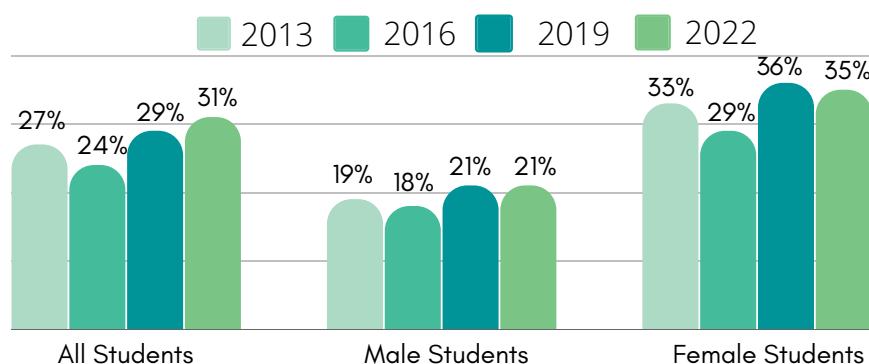

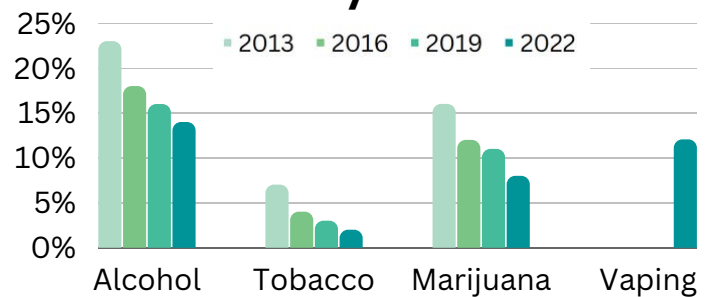

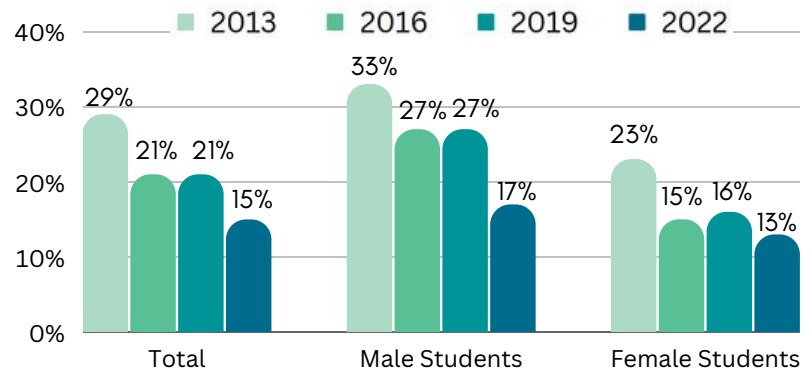

- Providing systems-involved youth with therapeutic services that are designed to help them process traumatic events, manage trauma-related distress, and develop effective coping strategies and skills
- Developing gang prevention, intervention, and education programs within the region to lessen harms of violence exposure and prevent further involvement in violence
- Supporting families at-risk of youth violence by creating and strengthening policies to improve household financial security, strengthen access to high quality childcare and education, and implement trauma-informed services
- Identifying youth at-risk of gang involvement and connect them with quality mentors and programs that foster social interaction and strengthen social connectedness

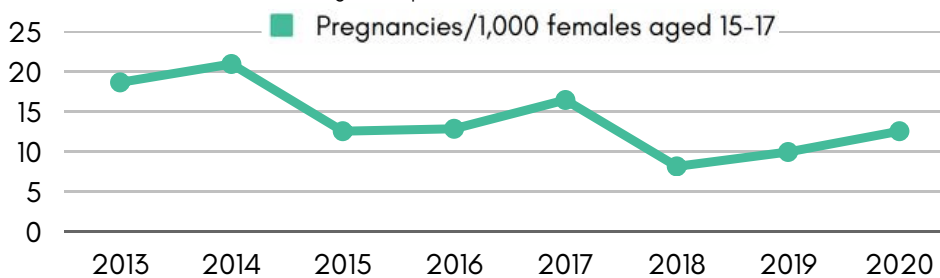

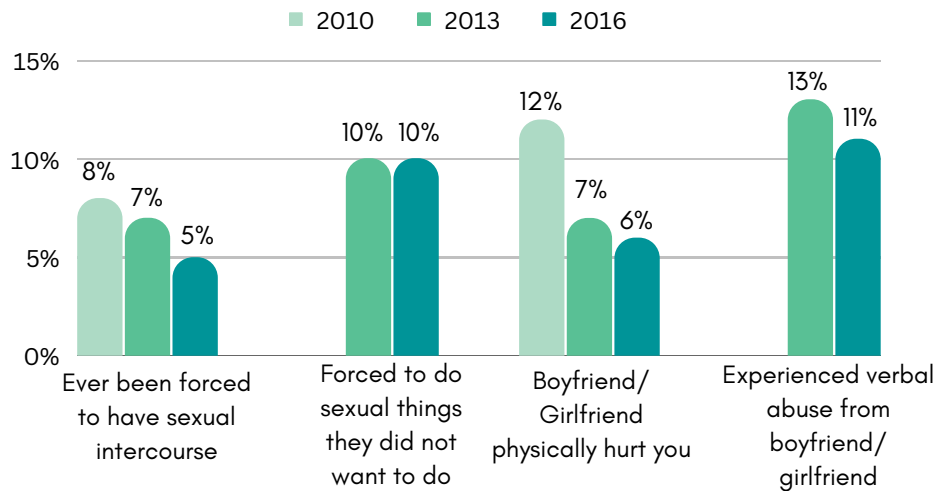

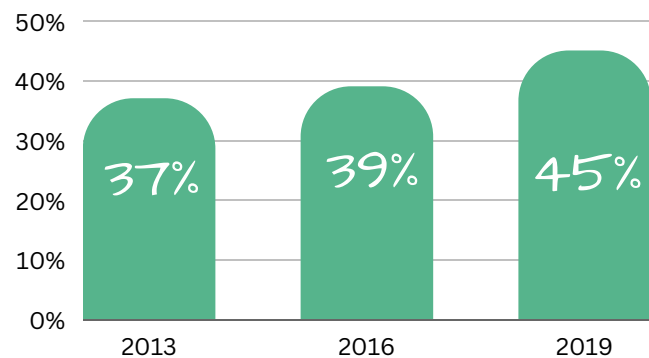

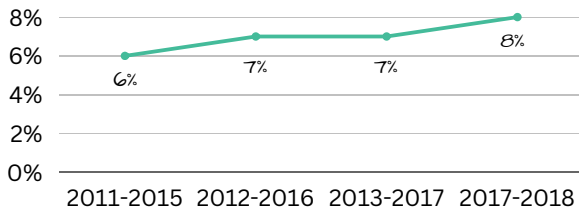

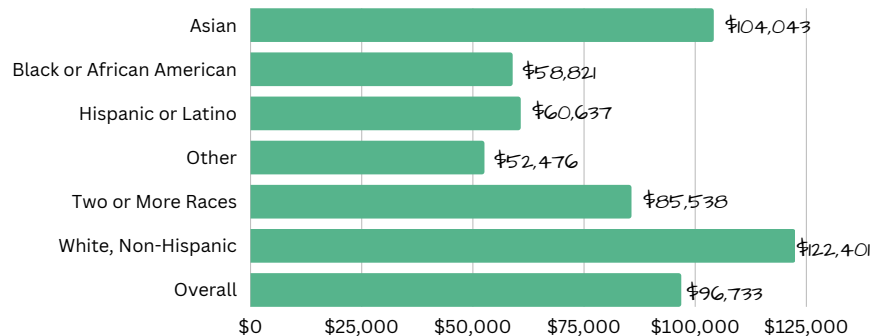
Families Living Below Poverty Level, Alexandria

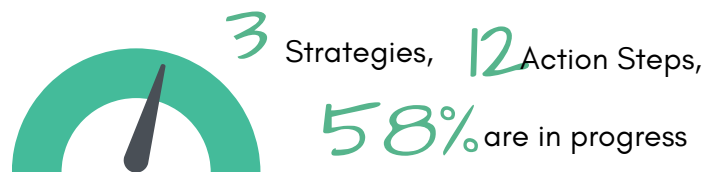

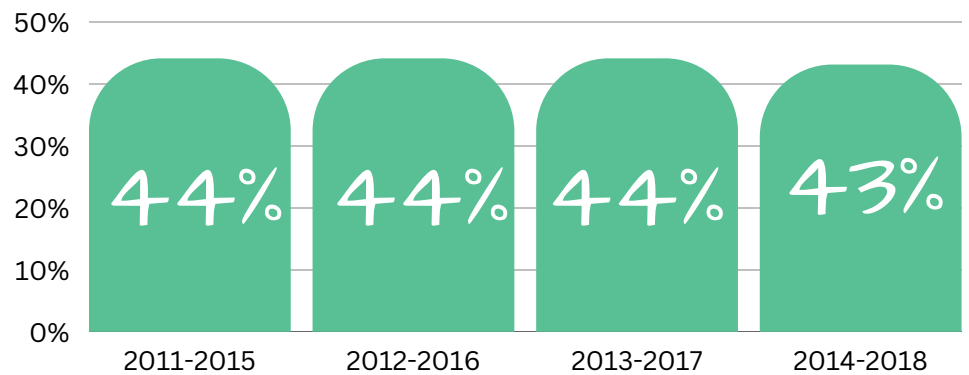

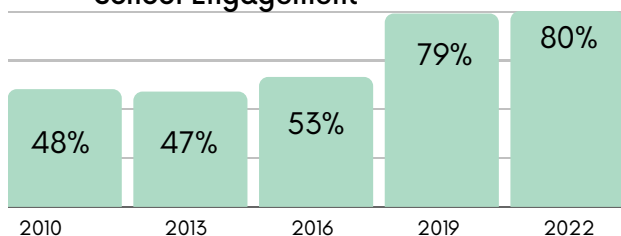

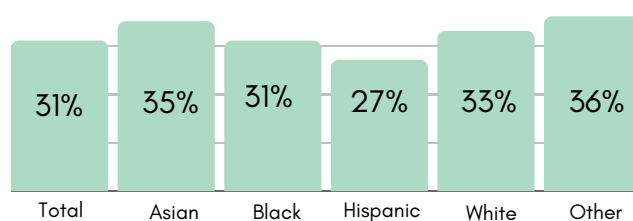

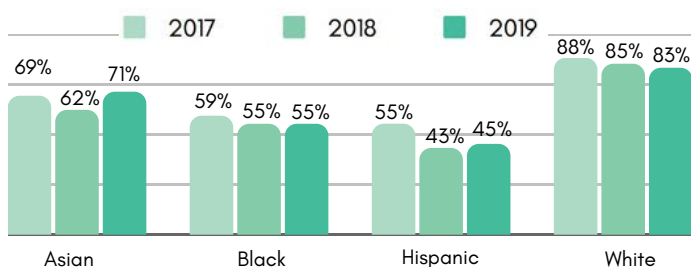

Caring School Climate by Race/Ethnicity, 2022



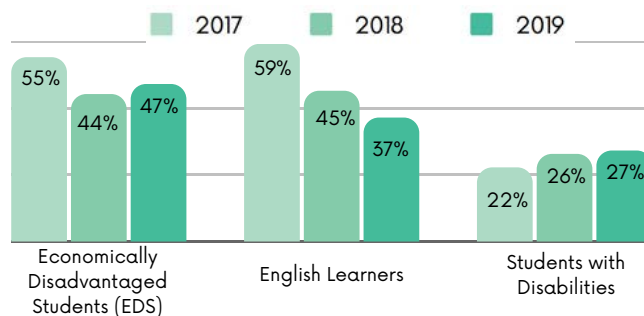

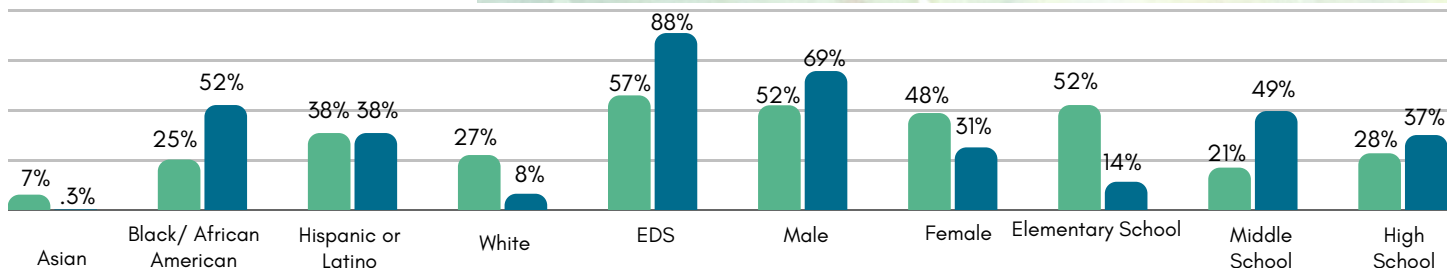
3rd Grade Reading by Sub-Group

Trends in Suspension Rates: The chart below depicts the percentage of students by demographic enrolled in ACPS compared to the suspension rate of that sub-group. Comparing these sets of data reveal many instances of disproportionality in suspensions at ACPS. For example, Black students comprise 25% of student enrollment and yet make up 52% of school suspensions. EDS comprise of 57% enrollment and yet make up 88% of school suspensions.

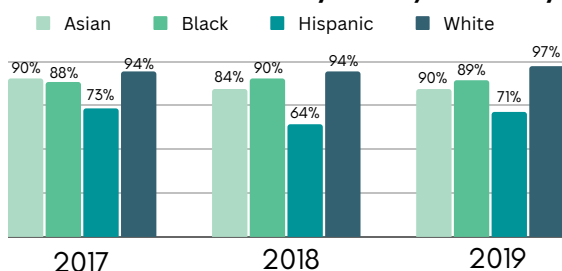

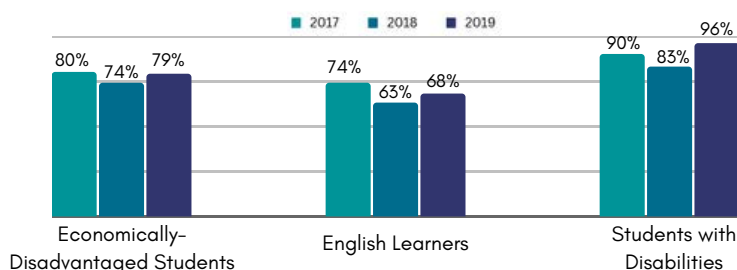

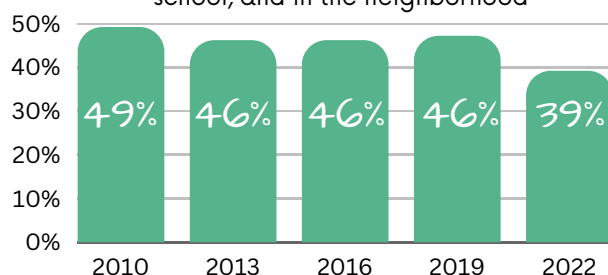

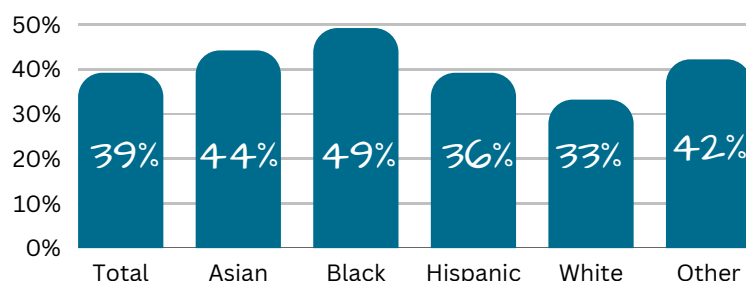

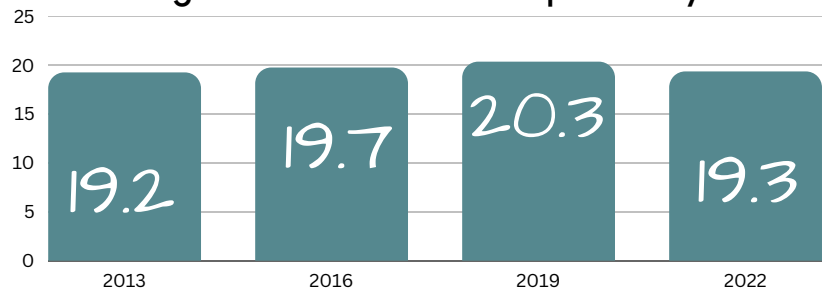

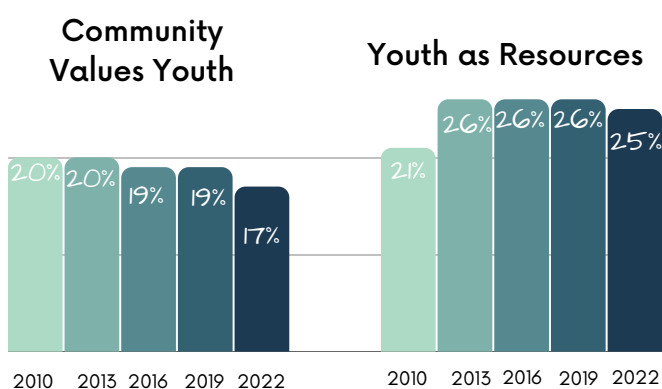

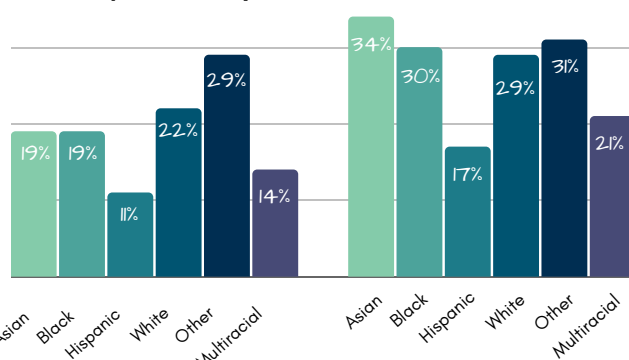

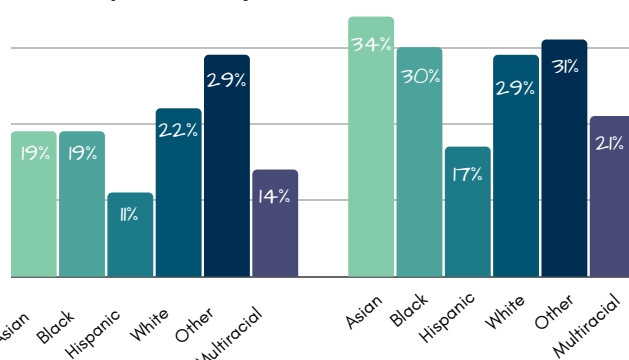

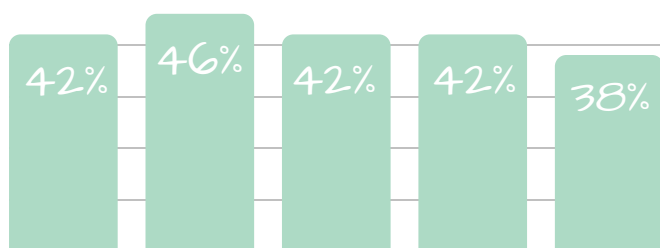

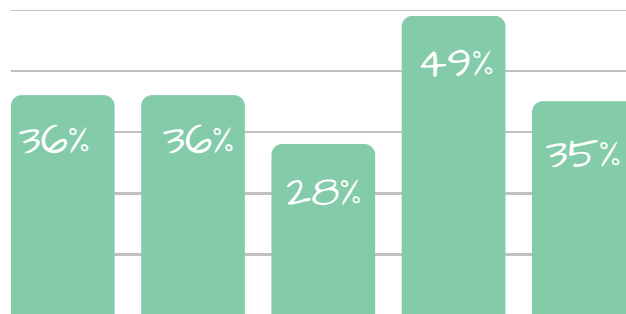

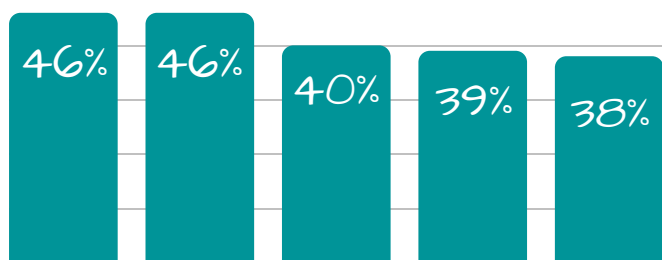

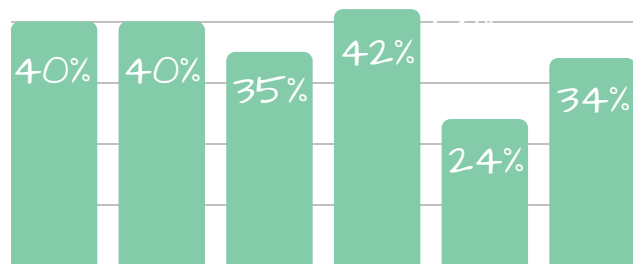

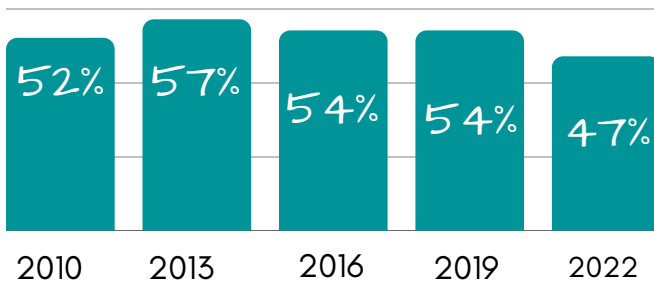

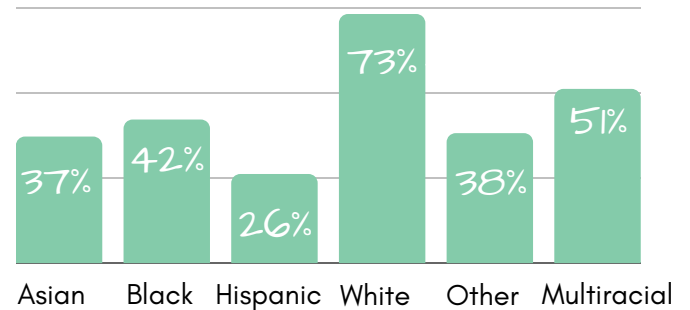

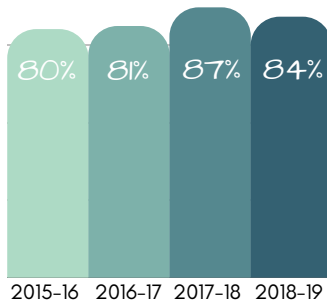

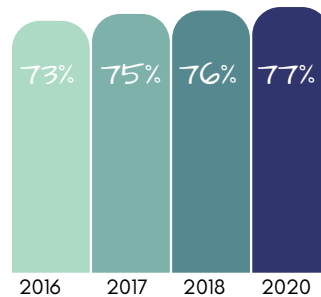

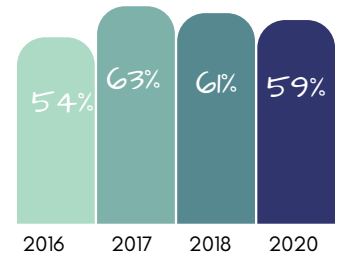
