4. Presentation from Build Our Future on "Tall Buildings, Small Energy Bills, Passive House at Scale

Webinar presented a variety of new buildings currently operating or in construction stage in New York – all with energy use intensities of around 20 EUI. These buildings used Passive House standards to mostly larger buildings. This Webinar followed an earlier one highlighting medium and smaller affordable housing projects in Philadelphia during EPC's April 2022 meeting. Topic is important because 60% of Alexandria's GHG emissions are associated with energy use in buildings. Presentation followed by Q&A.
