



Existing & Proposed Condition



- Thru-right lane on Sanger Ave leaving school
- Primarily used as right-only lane



- Convert thru-right to right-only
- No major impacts
- Removes need for two receiving lanes; potential for future curb extension
- Reduces conflict in receiving lanes
- No community comments

Recommendation

That the Board recommend that the Director of T&ES:

- ✓ Convert the southbound thru-right lane on Sanger Avenue to a right-only lane
- Eliminate the curbside eastbound lane on Sanger Avenue east of North Beauregard Street for up to 80 feet



Background

- Vision Zero Action Plan recommends developing a Neighborhood Slow Zone Program
- > 2022 City Council approval of lower speed limits in business and residence districts



About Neighborhood Slow Zones

What is a Neighborhood Slow Zone?

- Designated areas designed for slower speeds
- High-crash areas or areas with sensitive land uses that draw vulnerable users
- Designed to be self-enforcing

Common Features


- Slower speed limits
- Gateway treatments
- Traffic calming

Painted curb extension and gateway signs and markings








Lynhaven Slow Zone Project Webpage: alexandriava.gov/go/2928 In 2021, the City began the Lynhaven Neighborhood Slow Zone Pilot Project to respond to past neighborhood concerns about traffic safety. The purpose of this project is to create a "neighborhood slow zone" to encourage safer, more welcoming streets in Lynhaven. This project includes two changes that must be reviewed by the City's Traffic & Parking Board:

Lower Speed Limit:

To encourage slower speeds in the neighborhood, the City is proposing a 20 MPH speed limit for Montrose Ave, Wesmond Dr, Evans Ln, Wilson Ave, and Lynhaven Dr.

New Crosswalks & Parking Changes:

This project includes new crosswalks to make it easier and safer to walk to parks, the school, bus stops, and around the neighborhood. To ensure visibility of people using the crosswalks, some on-street parking is recommended to be removed. The proposed parking removals are shown in the enclosed map. The detailed design plans are also available on the project webpage, linked below.

Recommendation

That the Board recommend that the Director of T&ES:

- ✓ Reduce the posted speed limit from 25 to 20 mph on Montrose Avenue, Wesmond Drive, Evans Lane, Wilson Avenue, and Lynhaven Drive
- Remove 7 parking spaces in the Lynhaven neighborhood to improve pedestrian safety

Goals of Proposed Code Modifications

- Streamline the review process while ensuring city standards are met
- Delegates the approval authority to Director of T&ES or any designated agent. Authority currently resides with the City Managers Office.
- Modifies the appeal process to include only curb cuts that do not meet City standards.

Appeal Process


Appeals to the Traffic and Parking Board will be available only to proposed curb cuts that do not meet all the following criteria

- The curb cut is on a roadway that has a classification no greater than local per the most recently approved and adopted VDOT's Functional Classification
- One Curb cut per lot
- Curb Cut is located greater than 50' away from a bus stop
- Curb Cut is located greater than 30' from an intersection
- Curb Cut has adequate sight stopping distance per Virginia Department of Transportation Standards
- Curb Cut Meets T&ES Construction Standards

Modifications to Workflow

- No changes to the workflow for curb cuts proposed on DSUPs and DSPs
- A separate curb cut application will not be required for Curb Cuts proposed in associations with a Grading Plan
- No changes to the workflow for Curb Cuts proposed with a stand alone Curb Cut Application

Modified Curb Cut Ordinance Workflow



Recommendation

That the Board makes a recommendation to the City Council to amend and reordain Section 5-2-14 of Article A (GENERAL PROVISIONS) of Chapter 2 (STREETS AND SIDEWALKS) of Title 5 (TRANSPORTATION AND ENVIRONMENTAL SERVICES) of the Code of the City of Alexandria, Virginia, 1981, as amended.
