There will also be listening sessions with Alexandria families and middle and high school students.</li> <li>In conjunction with the Partnership for a Healthier Alexandria and Youth Support Network, the middle school programming was highlighted as one of our priority initiatives due to the historic shortage of Alexandria middle school students participating in OST programming. The Middle School Programming Work Group was created to identify strategies and solutions to expand middle school student engagement in OST and community-based programs.</li> <li>In conjunction with the Partnership for a Healthier Alexandria and Youth Support Network, the Social-Emotional Learning Work Group to identify strategies and practices that will support the professional development and well-being of staff and volunteers in fostering the social-emotional learning and development of youth. This effort will align with the Children &amp; Youth Community Plan and ACPS' Equity for All 2025 Plan. The workgroup is currently focusing on Developmental Assets and Developmental Relationships, but we plan to review the frameworks practiced by ACPS (Adult SEL, PBIS, Restorative Practices, RULER, Trauma-Informed Practices), and other research-based SEL frameworks.</li> <li>The Partnership for a Healthier Alexandria is working to build a community program locator with the data gathered from the landscape scan.
