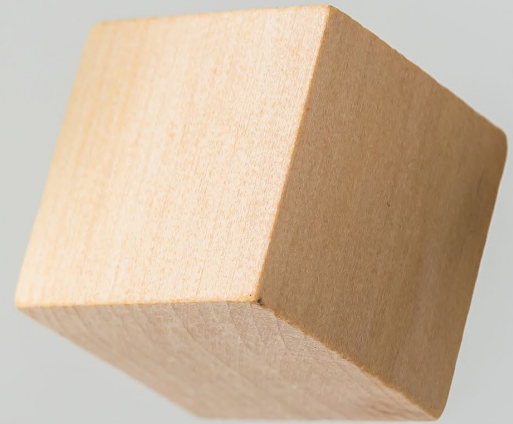
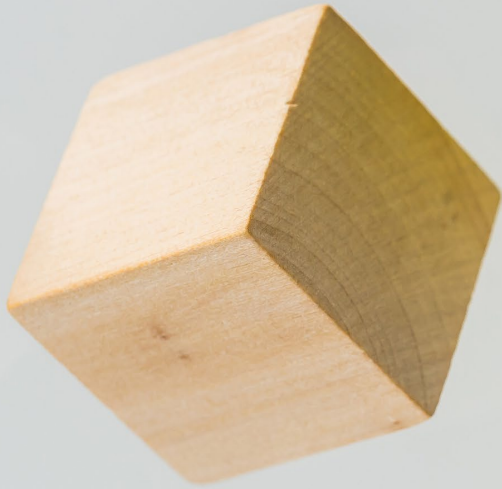
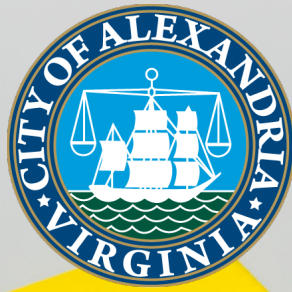

Who is the Legislative Director?

In 2001, joined the City of Alexandria as public information specialist for the Office of Historic Alexandria, later serving as the public affairs officer in the Office of the City Manager

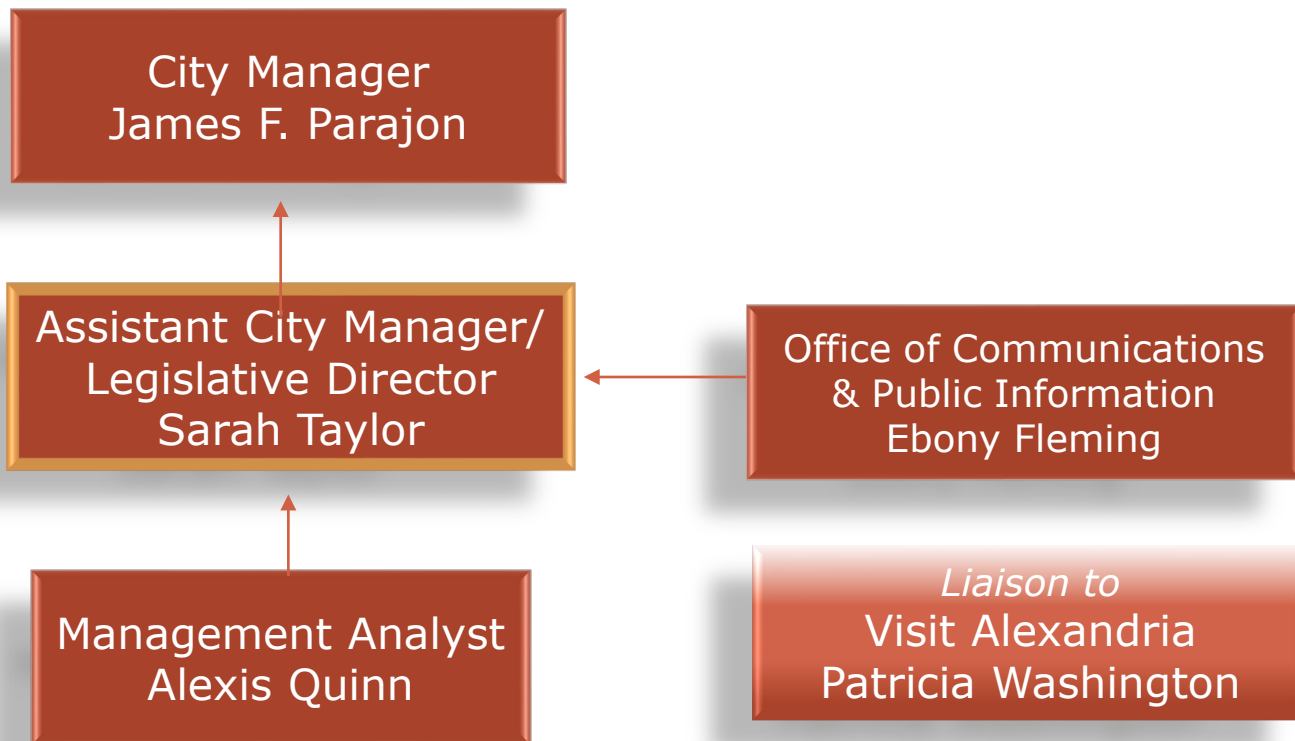
20-year career in legislative affairs, policy development, political strategy, public affairs and strategic communications

Served as Chief of Staff to the Democratic Caucus in the Oklahoma State Senate, appointed by the Senate President Pro Tempore at the advice of the Minority Leader

Served in legislative, public engagement positions with Henrico County, VA, and the cities of Bristol and New Haven, CT, and as a consultant for San Francisco County and the City of Richmond, CA

Re-hired in January 2018 as the City's Legislative Director. Promoted to Assistant City Manager in March 2021.

No Really...What is a Legislative Director?



- Represents City Council's legislative agenda before the Virginia General Assembly and the U.S. Congress;



- Serves as the City's primary liaison to the executive branches of state and federal government;



- Coordinates, executes City efforts to influence state and federal legislation, appropriations and regulations.

What Does the Legislative Director Do?

The Legislative Director serves as an effective advocate for Alexandria's community needs in Richmond and Washington by:

- Identifying and advancing legislative and budget proposals which support the City's delivery of efficient and effective services to the community and are in line with the City's strategic plan as well as its mission, vision and values;
- Identifying and working to influence and/or defeat legislative and budget proposals which have a negative impact to the City's strategic plan;
- Engaging City Council, City staff, Boards and Commissions, and the public as subject matter experts and advocates of City legislative and budget priorities.

What Does the Legislative Director ACTUALLY Do?

Provides legislative guidance

Reviews all legislation in the General Assembly

Develops Council's annual legislative package

Tracks and reports on legislation

Coordinates with other local government legislative liaisons and associations statewide

Attends interim public hearings, meetings

Coordinates, facilitates implementation of new legislation

Represents the City with Congressional delegation

Why Does the City Need a Legislative Director?

Localities in Virginia request legislation every year to grant them enabling authority they do not already have.

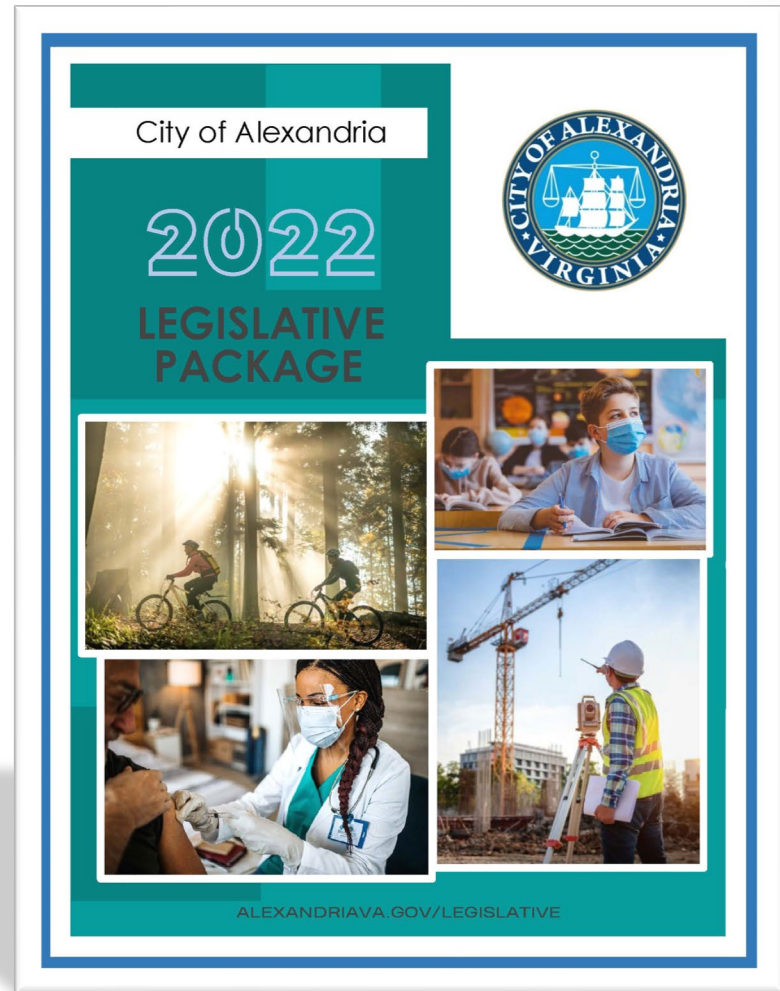


Virginia is a Dillon Rule state

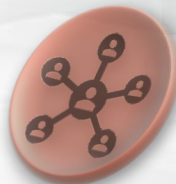

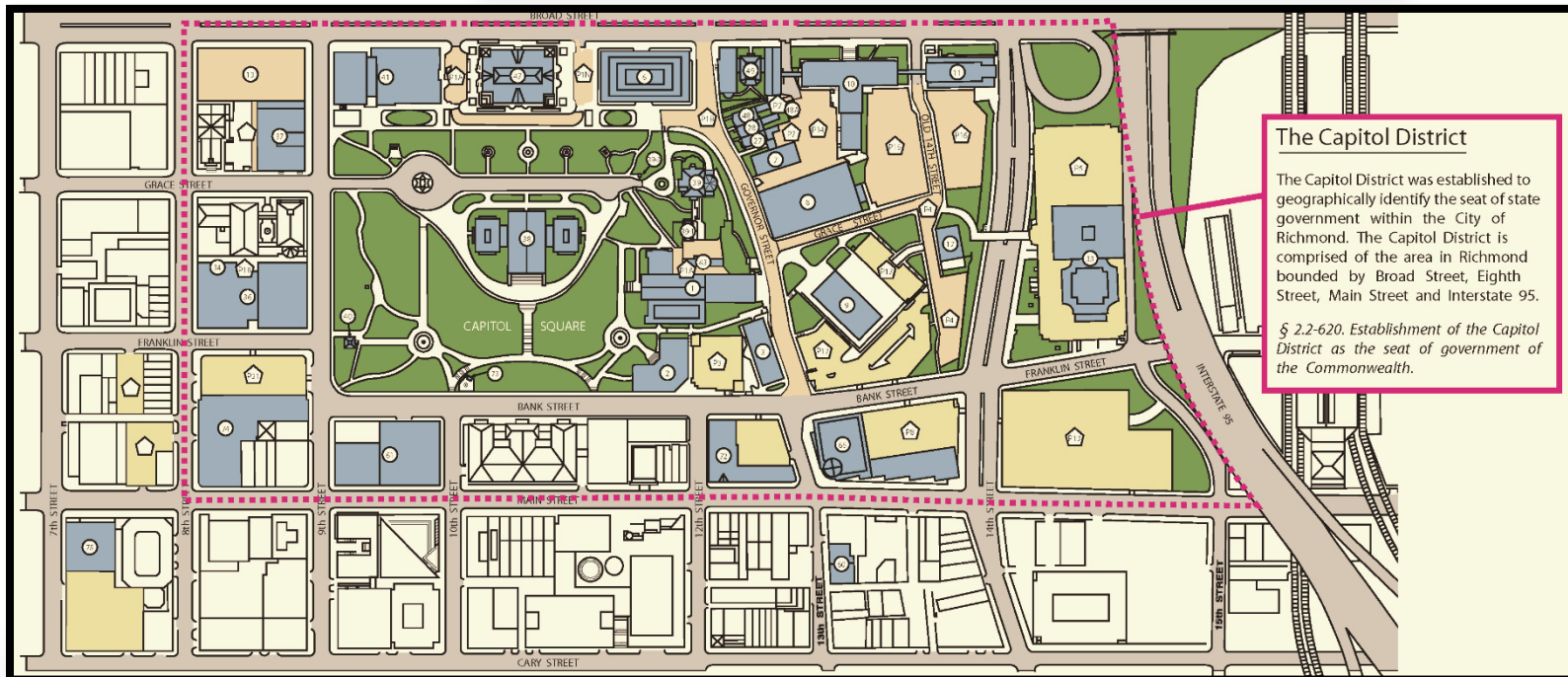
Package is considered by Council

Now What?

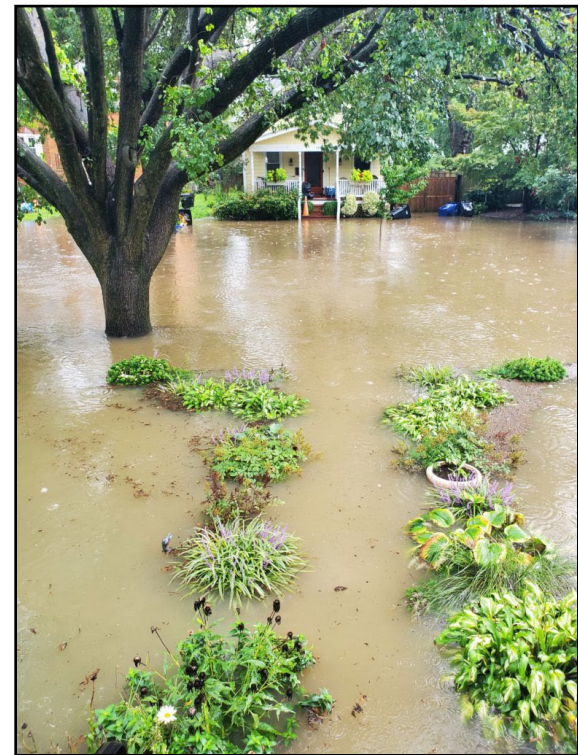
The Legislative Package serves as the “**marching orders**” for the Legislative Director during session.



Case Study: Flood Mitigation Grants

The City supports authority and funding to support localities dealing with the impacts of inland and urban flooding, especially in low-income neighborhoods and impacting vulnerable communities.

*Proposal: The City supports...legislation evolving the **existing authority** granted to localities to establish a local Stormwater Management Fund, consisting of **funds appropriated by the City**, to include the authority to use the grant funds **on private property** for **flood mitigation and protection measures** with a clear public benefit, such as floodproofing and flood protection products, and grading.*





Case Study: Flood Mitigation Grants

SB 1309 Local stormwater assistance; flood mitigation and protection.

Introduced by: Adam P. Ebbin

SUMMARY AS INTRODUCED:

Local stormwater assistance; flood mitigation and protection. Authorizes grants from a local Stormwater Management Fund to be used for measures that are part of a comprehensive flood mitigation and protection plan adopted by the locality, including floodproofing, flood protection products, and grading. Current law allows such funds to be used only for the construction, improvement, or repair of a stormwater management facility or for erosion and sediment control.

Case Study: Flood Mitigation Grants

Alexandria's Goals:

- Grant localities the authority to use local Stormwater Management Fund monies for grants to private property owners for flood mitigation and protection projects
- Ensure flexibility with regard to the kinds of projects eligible for grants



SUMMARY AS PASSED SENATE: (all summaries)

Local stormwater assistance; flood mitigation and protection. Authorizes grants from a local Stormwater Management Fund to be used for flood mitigation and protection measures that are part of a comprehensive flood mitigation and protection plan adopted by the locality, and requires such grants, where practicable, to prioritize projects that include nature-based practices. Current law allows such funds to be used only for the construction, improvement, or repair of a stormwater management facility or for erosion and sediment control.

Case Study: Flood Mitigation Grants

Be it enacted by the General Assembly of Virginia. . .

1. That § [15.2-2114.01](#) of the Code of Virginia is amended and reenacted as follows:

§ [15.2-2114.01](#). Local Stormwater Management Fund; grant moneys.

Any locality may by ordinance create a local Stormwater Management Fund consisting of appropriated local moneys for the purpose of granting funds to an owner of private property or a common interest community for stormwater management and erosion prevention on previously developed lands. Grants from such fund shall be used only for *(i) the construction, improvement, or repair of a stormwater management facility* ~~or for~~; *(ii) erosion and sediment control; or (iii) flood mitigation and protection measures that are part of a comprehensive flood mitigation and protection plan adopted by the locality. Grants made pursuant to clause (iii) shall, where practicable, prioritize projects that include nature-based practices.*

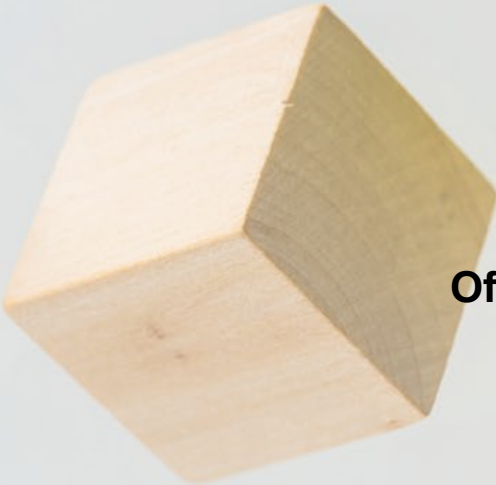
