
#### **INCIDENT ONE**

#### NEWBORN DELIVERY

SEPTEMBER 22

On the morning of September 22, Public Safety Communications Officer Autumn Harding fielded a 9-1-1 call from a husband whose wife was about to go into labor. Within 47 seconds of the call, Officer Harding had two resources from Alexandria Fire Department responding. As the scene became increasingly frantic, Autumn encouraged the father to stay on the line and provided pre-arrival instructions. Within 3 minutes and 40 seconds, the baby had been born. Once first responders arrived, the family was transported to the hospital for evaluation.

Officer Harding's ability to fall back on her training resulted in a successful at-home delivery. For this incident, Autumn Harding is receiving a Life Saving Award.

### INMATE RESCUE

**AUGUST 28**

Shortly after midnight, on August 28, an inmate who had been booked into the William G. Truesdale Adult Detention Center experienced a medical crisis. Master Deputy Hafsa Munir was working in the booking area and observed the crisis through security monitors. Sergeant Brian Wade responded after Deputy Munir called for help. Sergeant Wade worked quickly to rescue and escort the inmate for evaluation. Protocols were put into place to keep the inmate safe for the duration of incarceration.

Deputy Munir's attentiveness and Sergeant Wade's swift actions prevented the death or serious injury of an inmate. For this incident, Hafsa Munir and Brian Wade are receiving Life Saving Awards.

On the morning of March 10, Deputy Joseph Walker was on duty at the William G. Truesdale Adult Detention Center when he texted an off-duty colleague. During the text exchange, he noticed something off with his colleague's responses and that immediate help was necessary. Deputy Walker made telephone contact with his colleague and notified his commander. Sergeant Victor Ignacio and Captain Dave Cutting were assigned to take over the phone conversation and begin crisis negotiations. The team worked in conjunction with Emergency Communications to track and locate the telephone connection. Crisis negotiations spanned 20 minutes as police personnel made their way on site.

Deputy Walker, Sergeant Ignacio, and Captain Cutting's ability to identify a concern, establish rapport, and rely on their instincts, enabled them to rescue one of their own. For this incident, Joseph Walker, Victor Ignacio, and Dave Cutting are receiving Life Saving Awards.





#### GUNSHOT RESCUE

On July 7, officers responded to a "weapons violation" call in Old Town. When Officers Lemar Gardizi and Daniel Zapata arrived on scene, they located a victim suffering from a gunshot wound to the upper thigh. Realizing the severity of the injury, they immediately rendered aid and placed a tourniquet on the victim. They kept the individual alert until Alexandria Fire personnel arrived. Treating doctors indicated that the bullet had struck a significant artery, which within 5 minutes could have been fatal.

Officers Gardizi and Zapata's quick actions saved the life of a citizen of our community. For this incident Lemar Gardizi and Daniel Zapata are receiving Life Saving Awards.



#### INCIDENT FIVE

#### BURGLARY TURNED DOUBLE HOMICIDE RESPONSE

JULY 16

On the morning of July 16, Officers Adam Bing, Phillip Morse, and Robert Honaker were dispatched to a burglary in progress at a large apartment complex fairly close to Fairfax County. Upon arrival, officers learned that the suspect had fled from the burglarized unit. Officers believed the suspect could be the same offender from a previous incident. Since a handgun was used during the previous incident, officers were now looking for a potentially armed individual running free through a large apartment building. Units requested a canine team, but Alexandria units were unable to deploy. Alexandria reached out to Fairfax County Police for support and Officer Kevin Gemmell and K9 Ajax reported to the scene.

Officers worked to clear the building and associated parking garage. A second call for "shots fired" was received from a property two buildings away. This team responded and discovered two deceased construction workers. The complainant provided a description which matched the suspect of the burglary. As additional resources arrived at the scene, this team continued the search.

A third burglary call came from a woman who had barricaded herself in a room with her son. The team entered the building and apartment, taking cover and bounding. After three attempts to access the apartment, the woman and her son emerged. Officer Morse placed himself between the family and the apartment door.

Knowing the suspect may attempt to flee the unit from inside, Officer Gemmell made the difficult decision to send K9 Ajax into the scene. Ajax disappeared into the back rooms of the apartment. The team heard screaming and discovered Ajax had caught the suspect. An arrest was made, a weapon seized, and the reign of terror concluded.

Officers Adam Bing, Robert Honaker, Phillip Morse, and Kevin Gemmell, having never met before, worked together in the face of almost certain injury and possible death. For this incident, Adam Bing, Phillip Morse, Robert Honaker, Kevin Gemmell, & Ajax are receiving Silver Medals.

#### INCIDENT SIX

#### INFANT RESCUE

#### **AUGUST 22**

During the early morning hours of August 22, Alexandria Fire Department Engine 205 was dispatched for a fire alarm activation. As the crew pulled up to the door of the 5-story apartment building, a person was observed laying in the vestibule of the building across the street. The team called out to the person, who began screaming and kicking the doors. The crew also observed the person was holding an infant to their chest and may have a chemical impairment.

Captain Jeffrey Taylor directed Lieutenant Jason Sharpe and Firefighter Antonio Tizol to investigate the fire, while Firefighter Joseph White remained in the vestibule. Shortly after calling for police back-up, the individual began to roll, continuing to clutch the infant. The child stopped moving and the reassembled crew of four, having called police, acted fast to rescue the small child. The crew moved the infant out of the vestibule and restrained the individual until police arrived. The crew evaluated the infant and called for a truck to remove smoke from the other building.

Captain Jeffrey Taylor, Lieutenant Jason Sharpe, Firefighter Antonio Tizol, Firefighter Joseph White acted quickly to asses two concurrent scenes and incidents. Their rapid response and attentiveness saved the life of a child. For this incident, Jeffrey Taylor, Jason Sharpe, Antonio Tizol, and Joseph White are receiving Life Saving Awards.


