



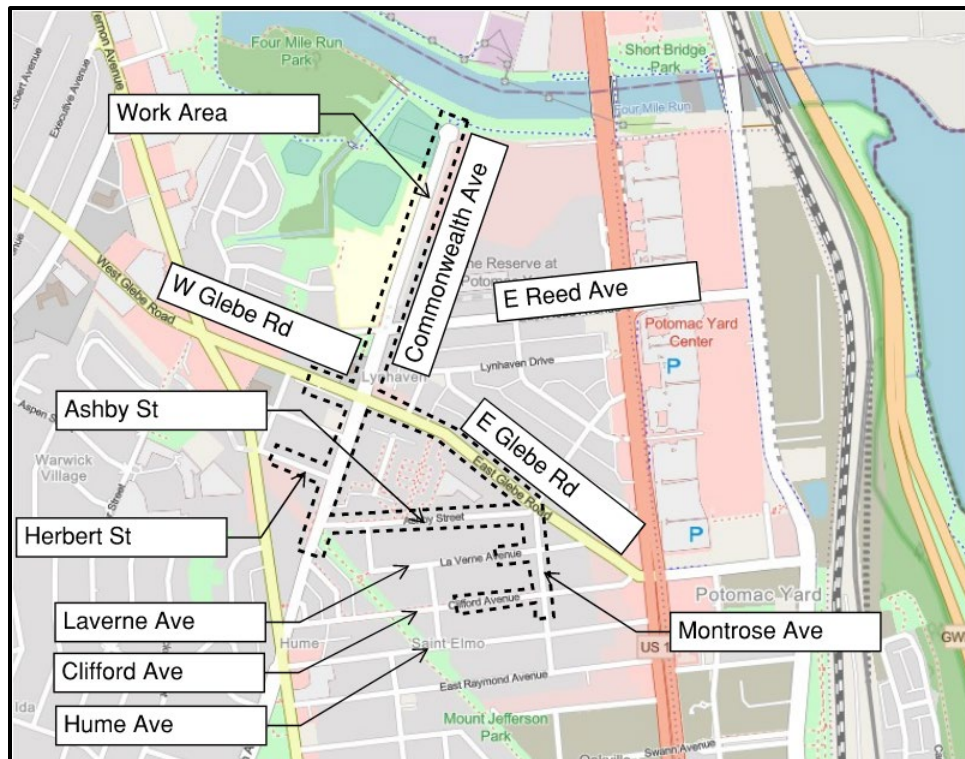

STORM SEWER UTILITY WORK NOTICE: AUGUST - SEPTEMBER 2023

For Commonwealth, Ashby, and Glebe Flood Mitigation Project



This notice is to inform City of Alexandria residents in the immediate proximity of the Commonwealth, Ashby, and Glebe Flood Mitigation project that geotechnical boring and exploration work is scheduled to be performed in the area. Contractor crews will operate drilling equipment to sample the underlying soils and confirm that they are acceptable to support the proposed work. Boring work is anticipated to last seven (7) weeks total. The tentative schedule for work is estimated between **August 2nd, 2023, to September 15th, 2023**, weather permitting.

Utility Work Notice

Each drilling location will require a day of preparation and a day to drill, which will occur a week after the preparation day. Traffic controls will be provided around work equipment. No Parking signs will be posted at least 3 days in advance of work in parking areas where drilling will occur. There will be no disturbance or impacts to your private property. Access to driveways and building entrances will be maintained. Contractor operations will adhere to City noise and construction ordinances.

Construction work limits for each roadway are listed below:

Commonwealth Ave: 9:00 AM – 3:30 PM, Monday through Friday

Herbert St: 7:00 AM – 5:00 PM, Monday through Friday

E Glebe Rd: 9:00 AM – 3:30 PM, Monday through Friday

Ashby St: 7:00 AM – 5:00 PM, Monday through Friday

Montrose Ave: 7:00 AM – 5:00 PM, Monday through Friday

Laverne Ave: 7:00 AM – 5:00 PM, Monday through Friday

Clifford Ave: 7:00 AM – 5:00 PM, Monday through Friday

Anticipated schedule for work is as follows:

- **Commonwealth Ave from Northern City Limits to just south of Ashby Street (work will progress north to south):** Week 1 to Week 4 (8/2/2023 – 8/25/2023)
 - **Herbert St:** Week 2 to Week 4 (8/7/2023 – 8/25/2023)
 - **W Glebe Rd, near intersection of Commonwealth Ave:** Week 2 to Week 5 (8/7/2023 – 9/1/2023)
 - **E Glebe Rd, from Commonwealth Ave Intersection to Montrose Ave (work will progress west to east):** Week 2 to Week 4 (8/7/2023 – 8/25/2023)
 - **Ashby St, from Montrose Ave to Commonwealth Ave (work will progress from east to west):** Week 3 to Week 6 (8/14/2023 to 9/8/2023)
 - **Montrose Ave, from Ashby St to Hume Ave (work will progress from north to south):** Week 4 to Week 7 (8/21/2023 – 9/15/2023)
 - **Laverne Ave, near Montrose Ave Intersection:** Week 4 to Week 6 (8/21/2023 – 9/8/2023)
 - **Clifford Ave, near Montrose Ave Intersection:** Week 4 to Week 6 (8/21/2023 – 9/8/2023)
- Please note this is the anticipated schedule, but it is subject to change due to weather or unexpected field conditions.**

As always, please be mindful of contractor crews working in or alongside the roadway.
