

#### I. Establishment of a Quorum

• Meeting called to order at 5:33 pm by Chair Jerome Cordts (JC); role taken.

#### II. Approval of the June 2023 Minutes

• JeanAnn Mayhan (JM) motioned to approve July 2023 minutes, Sylvia Jones (SJ) Second. Minutes approved with minor edits.

#### III. Review Agenda

JC reviewed the meeting agenda format with the commissioners.

#### IV. Update from the Chair

 Met with Dr. Rose and Natalie. Discussed AHD turnovers and resource intensiveness of public health activities.

#### V. Topical Issues for Discussion

- Medicaid Unwinding Update
  - Patrick Okoronkwo provided an update on Medicaid Unwinding

- The department is processing renewal applications for approximately have renewed 2,000 households. Approximately 1,100 individuals were terminated- there could be multiple reasons. Investigating these reasons. Will need to process 9,000 by February 2024.
- The state has been issuing rules/actions and then coming back with updates in a short amount of time causing confusion.
- High level of elderly and disabled residents level in Alexandria. These applications cannot be expedited and require full review.
- The biggest issues have been residents not returning their renewal packets. Some issues with addresses, initial automated mailing had significant issues causing many undeliverable packets. Have worked with post office and automated systems to reduce that number.
- When residents apply for other benefits, they are asking them to follow up with their Medicaid applications.
- Patrick asked that any of our departments ask our patients to go up to the 5th-floor DCSH Public Benefits office to pick up and get assistance on their Medicaid package. The customer relations staff is well-staffed, but no outreach staff.
- Working with the State for accurate local data.
- Commissioners asked about resources in the department for processing staff and outreach.
- AHD offered to share information in our clinics and provide flyers at outreach events through MRC. Natalie will connect Patrick with MRC coordinators for additional assistance with Neighborhood Health also offered to share information with their patients.
- Commissioners also asked how many residents might be at risk of losing their coverage. 34,000 individuals with coverage and between 6-8,000 residents are at risk of losing coverage.
- Managed Care Organizations have not been proactive about contacting patients about renewals.
- PR suggested writing a letter to Council. LC agreed that the issue is urgent and should be magnified to local leaders.
- Motion to raise awareness to Council on the urgency of Medicaid Unwinding. PR motioned, RM second. All in favor. Council resumes in September. Goal to submit by end of August.

#### Legislative Priorities Review

- Commissioners received the request for policy items. The process has changed from previous years.
- Reproductive health services and smoking cessation were submitted last year.
- Called for commissioners to draft any legislative items under the new process.

- INOVA Cares and AHD have community health workers who are funded through grants only. PR proposed this as a submission this year.
- Reproductive health and community health workers- PR will work on the draft for these two items.
- LC Medicare proposed fee schedule, adding an opportunity for community health workers to have some reimbursement for specific provided services. This supports PR's proposed items. LC and PR to work together on this topic.
- AR- has a topic on Maternal Child Health for a priority item and will submit a draft for review. The Dying Too Soon Report shows support for MCH PHAC and will review this as well.
- JC will meet with Sarah Taylor to get clarifications for moving forward in the new process.

- Gun Safety- will continue to work on this. Including Councilwoman Bagley to speak with the commission again.

#### VII. Health Department Update

- No new updates on local administration. Continue to work with neighbors who have gone through the process in the past
- Fall coming up, AHD will be doing a fall vaccine campaign
- Typically AHD received vaccines for community events. AHD will not receive any this year. All residents will have to go through eligibility to receive fall vaccines from AHD. AHD will not hold large-scale flu vaccine events.
- COVID vaccines will be commercialized by fall and AHH will keep the commission updated as more information comes forward.
- Working with ACPS on routine childhood vaccines
- AHD continues with Chronic Disease work. ALXBreathes for asthma and COPD. Beginning work on diabetes, have begun having more informal conversations with the public in development. The community needs health literacy, AHD will be looking into that. Unfortunately, this work is being completed by CHWs who's grant expires in May.
- RM asked if AHD had data on Long Covid- don't have local data only the rates of it. Estimated that 3-5,000 could be impacted by long COVID. NT will share data sources with the commission.

Flora Krause Casey (1904-1991) was a longtime resident of Alexandria and a dedicated advocate for the health of disadvantaged persons. In the late 1930s, Mrs. Casey assumed responsibility for a clinic that the Kiwanis Club formed to provide pre-camp physical exams. After two years of providing those services, it was apparent that families of lesser means needed to access medical services and a comprehensive clinic to provide that kind of care. Mrs. Casey fostered this clinic's growth as the community needs expanded. She was especially gifted at generating volunteer support and raising funds.

It is in her honor that the Public Health Advisory Commission continues her legacy by seeking and recognizing other individuals of like purpose, devotion, community advocacy, and leadership.

The Public Health Advisory Commission proposes that our state, Virginia, expand and fully implement a minimum of 6 weeks of paid family leave for all new parents. This policy is designed to prioritize the health and well-being of mothers and babies, ensuring that parents have the necessary time and financial support to bond with their newborns and access essential postpartum care.

#### **BACKGROUND:**

Paid family leave policies have shown profound positive impacts on the health and well-being of both parents and children. Such policies lead to increased postpartum care, especially among women of diverse racial groups, and result in beneficial outcomes like increased breastfeeding rates, timely vaccinations for infants, and a decrease in hospital admissions for pediatric abusive head trauma. However, in states without comprehensive paid family leave, many new parents are left to rely on the federal Family and Medical Leave Act (FMLA), which offers only unpaid, job-protected leave. While

Virginia has taken a step in the right direction by providing eligible state employees with 8 weeks of paid family leave benefits, there's an opportunity to use this as a foundation and expand these benefits to all Virginians. This proposal aligns with the city's priority to "Support Youth and Families" and resonates with the secondary priority to "Provide Diverse Housing Opportunities."

#### **Additional Background Information:**

The Prenatal-to-3 (PN3) policy clearinghouse (<a href="https://pn3policy.org/pn-3-state-policy-roadmap-2022/va/">https://pn3policy.org/pn-3-state-policy-roadmap-2022/va/</a>) is a comprehensive resource that evaluates the effectiveness of state-level policies and strategies that impact the early life of children, from prenatal stages to age three. Their rigorous research and evidence-based approach have highlighted the undeniable benefits of paid family leave. According to PN3, state paid family leave programs not only improve the economic security of families but also play a pivotal role in enhancing child and parental health and wellbeing. By allowing parents the time and financial security to bond with their newborns, these programs foster better child-mother relationships, increase the likelihood of timely and preventative health care, and even impact the mental health of parents positively.

In line with the Council's priority to "Provide Diverse Housing Opportunities, the "Healthy Parents Healthy Babies" report (<a href="https://housingequityframework.org/healthyparents-healthybabies">https://housingequityframework.org/healthyparents-healthybabies</a>) offers insights into the challenges faced by pregnant individuals and new parents experiencing homelessness or housing instability. While the report's primary focus is on housing stability during the perinatal period, it underscores the broader challenges that can be alleviated with supportive policies like paid family leave. The report suggests that providing both housing and income support during the perinatal period can significantly improve maternal and infant health outcomes.

### **Maternal Mortality:**

a death occurring during pregnancy or within one year of delivery resulting from a pregnancy complication (CDC)

## **Infant Mortality:**

the death of a child under one year of age (CDC)

Black birthing people and babies are far more likely to suffer from pregnancy-associated deaths than their White counterparts due to systemic racism

# Black women in VA are 6 times more likely to face racial discrimination during pregnancy than White women

- Virginia is ranked 25<sup>th</sup> in the country for lowest maternal mortality rates
- VA's maternal mortality rate has not seen a decline since 1982
