 - 1. <u>Call to Order and Roll Call:</u> Chair Dillon called the meeting to order at 6:05pm. All present confirmed their attendance.
 - 2. <u>Approval of Previous Meeting Minutes:</u> Ms. Buttar made a motion to approve the minutes. The motion was seconded, and members approved.
 - 3. City Council Opening Comments: None.
 - 4. Public Comment: None
 - 5. <u>Partner Updates:</u> Officer Evans spoke about the recent shooting incident that occurred on Wythe Street and stated that there is no information to provide at this time regarding the shooting. The Alexandria Police department is in the process of putting more officers in the neighborhoods to patrol the areas.

6. Chairman's Readout:

Revisiting our lenses: Chairman Dillon revisited the lenses and continued to focus on the target to best help:

- o At-Risk and At-Promise kids vs. Crew and Gang members.
- Advocate to support our partners efforts.
- Build opportunities and try to create resources outside of school and home time,
 i.e. after school, weekends and summer.

- Widen our age target, as early as 5th grade while also not losing site of the parents.
- o Look more critically at areas that face the biggest challenges.

Efforts We Have Completed:

- In partner with the CSU group, the Gang Prevention Task Force was able to supply 25 jerseys, uniforms, etc. for the SRO soccer program and also partnership with the Alexandria Police and the Sheriff's office potentially getting scrimmages on board.
- o Pillar Series: In the process of concluding the first pilot round of the Pillar Series.

Initiatives in Motion:

- The Junior City Academy is tentatively set to begin in the Fall on September 11, 2023, for 7 consecutive weeks. The academy will be supported by ACHS, Teacher Administration, etc.
- Sherriff's Cadet Program. Currently in the process of finding ACHS students who are interested in a career in Law Enforcement. Sheriff Casey stated that the Sherriff's Cadet program will model the Metropolitan Police Department Cadet Program which will act as a full-time job with benefits.
- APD and Recreation Center Cookouts: Seven cookouts have been held and there will be 3 Community cookouts held for the remainder of this month: May 18, 2023, at the South Port Apartments, May 23, 2023, at Adkins Housing and May 25, 2023, at the Mt. Vernon Rec. Field.
- 7. <u>Action Planning Readouts:</u> Reverend Oliver stated that he is attempting to organize a block party and has gathered with other pastors and Mr. Mike Johnson to prepare to host this event.

Ms. Cruz stated that she would like to conduct a soccer program in the summer that will be centered around Mental Health Awareness, however, funding is an issue. Ms. Cruz is currently networking and reaching out to foundations in order to obtain funding.

Chairman Dillon, Mr. Coates and Mr. Bailey are closing out the pilot Pillars series held at Charles Houston Recreation Center.

A second session of Pillars series is in the works and the team is looking to partner with Casa Chirilagua. Tentative start time is Fall 2023.

8. Current Environment:

Chairman Dillon led a discussion to help generate conversation in the room regarding a variety of topics impacting our schools and community. The discussion included a generalization of attendance levels of different students, where some of the current tension between youth members is occurring and pointed to potential solutions or needs in which the task force can focus. These items include:

- Additional IPE resources.
- Provide more activities/support of school hours.
- Begin to incent behavior.
- Reevaluate Truancy.

9. Bradlee Shopping Center Brainstorm:

Chairman Dillon led a brainstorm session with potential ideas to help offset some negative behavior that is currently occurring at Bradlee Shopping center.

Suggestions included, site modifications, increasing awareness, creating incentives, and the addition of prosocial activities to deter our youth from loitering at the shopping center.
