#### 3. DISCUSSION ITEM: Trails

**ISSUE:** Staff from the Department of Recreation, Parks, and Community Activities (RPCA) to provide update and information to the Transportation Commission on the trail maintenance and planning program and activities

**RECOMMENATION:** That the Commission receive this presentation.

**DISCUSSION:** Beth Znidersic, RCPA Department Division Chief presented an update on Trails and the upcoming projects.

#### 4. ACTION ITEM: RAISE Grant Application

**ISSUE:** The City is proposing to apply for the FY 2024 RAISE planning grant.

**RECOMMENATION:** That Transportation Commission endorse a letter to City Council in support of the United States Department of Transportation (USDOT) FY 2024 RAISE funding application.

**DISCUSSION:** Chris Ziemann, Transportation Planning Division Chief provided an overview of the RAISE Grant Application. Due to the proximity to the interstate and number of ramps connecting to this segment of Seminary Road, the Virginia Department of Transportation (VDOT) will be closely involved as a key stakeholder with any study in this area. Additionally, VDOT requires Operational and Safety Analysis Report (OSAR) to accompany any recommended changes that could involve access modifications to highway ramps. Conducting the planning early and in coordination with the state will set the City up for future success and expedited project delivery should recommendations that come out of this planning study come to fruition.

# 5. <u>ACTION ITEM: Virginia Department of Rail and Public Transportation (DRPT) Grant</u> Applications

**ISSUE:** The City is proposing to apply for the Virginia Department of Rail and Public Transportation (DRPT) FY 2025 Grant Programs.

**RECOMMENDATION:** That the Transportation Commission move to provide a letter of endorsement to City Council for FY 2025 DRPT State Aid Program Grant Applications through DRPT and NVTC:

- Up to \$37,000,000 in eligible expenses for State Aid Transit Operating Assistance
- Up to \$400,000 for State Aid Capital Assistance
- Up to \$350,000 for the Commuter Assistance Program (CAP)
- Up to \$110,000 for the Public Transportation Workforce Development Program
- Up to \$315,000 for the Demonstration Project Assistance Program
- Up to \$500,000 for the Transit Ridership Incentive Program (TRIP)

**DISCUSSION:** Chris Ziemann, Transportation Planning Division Chief presented information on six DRPT Grant applications.

The City and DASH plan to submit applications for six DRPT grant programs that will help offset City expenses and provide greater support for DASH. The programs all work toward the City's goal of supporting multimodal transportation options and reducing single-occupancy vehicle trips to relieve congestion.

Motion for the Transportation Commission to endorse letter to City Council in support of six DRPT grant applications: Vote called by Chair McMahon Motion carries unanimously.

## 6. ACTION ITEM: MWCOG Technical Assistance Grants

**ISSUE:** The City is proposing applications for two Metropolitan Washington Council of Governments (MWCOG) Technical Assistance Grants for FY 2025: one for the Transportation Land-Use Connections (TLC) Program and one for the Regional Roadway Safety Program (RRSP).

**RECOMMENDATION:** That the Transportation Commission move to provide a letter of endorsement to City Council for the proposed grant applications to the FY 2025 Transportation Land-Use Connections Program and Regional Roadway Safety Program.

**DISCUSSION:** Chris Ziemann, Transportation Planning Division Chief presented an overview of two MWCOG Technical Assistance Grants

Transportation Land - Use Connections Program - The City proposes to request technical assistance for the outreach and design of multimodal corridor improvements on Edsall Road between South Pickett Street and the City boundary. This corridor provides access to high-density residential communities, commercial and retail uses, mixed uses, Armistead Boothe Park, and public transportation, including the future West End Transitway. The project would include data collection, analysis, community engagement, and conceptual design planning for corridor improvements on Edsall Road to enhance mobility, access, safety, and comfort for all roadway users.

Regional Roadway Safety Program - The City proposes a request for technical assistance to study safety improvements along Seminary Road between North Beauregard Street and the City boundary. The project would include planning and conceptual design for corridor improvements on Seminary Road to enhance safety and comfort for all roadway users, including improvements to intersections, traffic signals, and lane configuration. In 2023, staff worked with the community to better understand concerns along this roadway and implemented some short-term solutions. Data was collected in fall 2023, and further analysis is needed to understand the feasibility of various design options that can improve safety along this corridor.

Both projects support strategies in the Alexandria Mobility Plan and address MWCOG Transportation Planning Board (TPB) priorities. These projects will result in the selection of a preferred design alternative which could then advance for further design. If funded, the project award would occur in Spring 2024, and projects would last from Fall 2024 to June 2025. Applications are due March 8, 2024.

**Commissioner McMahon** – Planning Commission discussed grid for collection of neighborhoods not being centered around cars.

**Commissioner McManus** – Attend the Dash Bus Advisory Committee meeting. They are moving forward on electric buses. Vendor is secure.

**SUBJECT:** AGENDA ITEM #4 – WMATA BUDGET

**ISSUE**: Consideration of the Washington Metropolitan Area Transit Authority (WMATA) FY25 Operating and Capital budgets.

**RECOMMENDATION**: That the Transportation Commission submit a letter to provide feedback on the FY25 budget.

**BACKGROUND**: On February 8th, the WMATA Board authorized Public Hearings on the Proposed FY2025 Operating and Capital Budget and FY2025-2030 Capital Improvement Program. The revised budget differs significantly from the General Manager's Proposed Budget, as draconian service cuts to rail and bus are largely avoided, fares are set to increase by 12.5% (20% was the original proposal), and the proposed closure of low-ridership stations has been scrapped.

Public hearings will occur in late February 2024, with anticipated budget adoption in April 2024, and implementation by the start of FY 2025.

**DISCUSSION**: FY 2025 Proposed Operating Budget includes revenue of \$487 million, expenses of \$2,352 million, total subsidy of \$1,769 million, and \$95 million of federal relief funding.

The FY25 operating budget gap of \$750 million is proposed to be closed by a combination of revenue increases, expense reduction techniques (such as one-time cost saving measures, wage and hiring freezes, etc.), a temporary lifting of the 3% cap on operating subsidy growth, and increased funding assistance by Compact partners.

The District of Columbia (\$200 million) and the State of Maryland (\$150 million) have publicly communicated providing additional subsidy dollars to help cover the operating budget gap. The Commonwealth has budget amendments moving through the General Assembly which would provide an additional \$130 million in assistance, which would require a 50% match by jurisdictional partners.

As mentioned above, the proposed operating budget avoids large service and frequency cuts to Metrobus and Metrorail, increases fares by 12.5% on Metrobus, Metrorail, and MetroAccess, and increases fares by up to 25% on late nights and weekends (\$2.50 cap).

Key rail service changes impacting Alexandria include a reduction in peak-period frequency windows from the current 4-hour periods in the morning and afternoon to 2-hour windows, slightly reducing Yellow Line frequencies on weekends, more 6-car trains, and the exploration of more service reductions on Federal Holidays (days with historically low-ridership). No bus service changes are expected in FY25, though the Better Bus network and formula is expected to be finalized in FY25 and implemented in FY26.

#### **Staff Recommendation**

Staff recommends that the Transportation Commission highlight the following themes related to the FY25 Metro operating budget:

- Prioritize consistent bus and rail service and frequencies to continue ridership recovery and reduce reliance on driving
- Commend WMATA for aggressive cost-saving measures
- Accept fare increases as necessary to keep up with higher costs (fares have not been raised in several years)

## Additional Operating Budget Comments

- Accept short-term increased subsidy as necessary
- Prioritize reducing or eliminating the need for additional measures for the projected FY26 operating gap

#### Dear WMATA Board of Directors:

Thank you for the opportunity to provide feedback on the proposed FY25 budget on behalf of the City of Alexandria's Transportation Commission. We applaud the proposed budget's delicate balance of aggressive cost saving proposals, targeted service reduction techniques, and reasonable fare increases.

The Commission appreciates the revised FY25 operating budget avoids many of the draconian cuts to Metrorail and Metrobus service and frequencies called for in the General Manager's proposed budget. At a time when transit ridership is increasing across the region, reliable service and convenient frequencies must continue to serve all riders.

The Commission also understands the need for the new proposal to increase fares in order to keep the pace with inflation and supports the installation of system-wide faregates to reduce fare evasion, though we must emphasize that these measures need to be in lockstep with increased use of Metro Lift and Senior reduced fare programs to help our riders in need.

WMATA's request for more subsidy funding from jurisdictional partners at the local level would normally cause concern, especially while accepting existing or reduced service levels. However, the Commission understands that the FY25 operating budget shortfall is a regional issue which requires a regional solution from all partners.

Looking ahead, the Commission urges WMATA to pay special attention to the future budgets because of the absence of dedicated funding, and to continue to work closely with compact

partners and jurisdictions to look at alternative funding options. The goal is to ensure that transit continues to serve the region's transportation needs and contributes to congestion reduction, greenhouse gas emissions reduction, and equity for all well into the future.

ISSUE: Staff update to Transportation Commission on various projects.

RECOMMENDATION: That the Commission receive the items for consent.

#### A. Annual Work Plan

The Annual Work Plan was updated based on the Commission's feedback in January. See Attachment 1.

#### B. No Turn on Red on St. Asaph Street

At its January 22 meeting, the Traffic and Parking Board approved No Turn on Red (NTOR) restrictions on North Saint Asaph Street at four signalized intersections:

- Pendleton Street
- Wythe Street
- Madison Street
- Montgomery Street

The NTOR treatments will be accompanied by Leading Pedestrian Intervals (LPIs) to help reduce crashes and protect pedestrians along this mixed-use corridor. NTOR and LPI treatments along North Saint Asaph Street will help toward achieving the City's Vision Zero goal of eliminating traffic fatalities and severe injuries by 2028.

Implementation of the NTOR restrictions is planned immediately.

## C. Sanger Avenue Improvements

City staff is working on providing safety and cycling mobility improvements along Sanger

Avenue as part of the upcoming paving project. The focus is on providing additional and safer pedestrian crossings, daylighting intersections due to pedestrian crashes and vehicular angle crashes and providing more buffer space for pedestrian and cyclists under the I-395 bridge near Van Dorn Street. Staff will share more information with community and present to the Traffic and Parking Board this Spring.

### D. Capital Bikeshare Highest Ridership Year

The Capital Bikeshare system hit record ridership numbers, both systemwide and in the City of Alexandria in 2023. The system rebounded from the decline in ridership seen during the COVID-19 pandemic. The number of trips taken by bikeshare has grown steadily since 2021 and 2023 was the highest ridership year for Capital Bikeshare in Alexandria to date. In 2023, 109,487 Capital Bikeshare trips started and/or ended in the City. Additionally, Capital Bikeshare had the highest average number of trips taken per day in 2023 with an average of 300 trips per day.

Capital Bikeshare ridership in the City can be viewed through the <u>Capital Bikeshare Trip</u> Data Dashboard.

This matches the City's success with DASH ridership as well, which saw its highest ridership year in history in FY23. The City is seeing real results from its investments in multimodal transportation.

## E. AlexWest Small Area Plan Update

On Monday, March 4, City staff will hold a virtual public meeting to discuss all the recommendations of the AlexWest Small Area Plan, including transportation and street layout recommendations.

For background, in Fiscal Year 2023, <u>City Council prioritized this planning process</u> to update the long-term vision for the <u>1992 Alexandria West Small Area Plan</u> and integrate the <u>2012 Beauregard Small Area Plan</u>. Creating an updated community vision allows us to proactively plan for change and prepare for challenges and opportunities in the years to come.

An updated Plan will:

- Enable the 10- to 30- year-old land use plans to be updated comprehensively to address current community needs and incorporate current City policies and best practices;
- Address the issue of housing vulnerability and affordability by leveraging housing resources, policies, and funding opportunities to meet this challenge; and
- Develop an approach to guide and shape future development and make expectations clear for the community, City and developers.

In November 2023, staff held a public meeting to discuss transportation elements of the plan.

## F. AlexMoves Multimodal Survey Update

In late 2023, the City partnered once again with the polling and research firm <u>Polco</u> its biannual AlexMoves travel survey to gain insight into how Alexandrians get around the City. This survey was the fourth of its kind and provides important information to help the City understand how its residents travel for all types of trips (not just the daily commute). In turn, this will help the City monitor changes over time and plan better for all transportation users. The City received the final report in January of 2024 and will present to the Commission later this year.

Below are just a few short takeaways from the survey:

## a. The addition of more off-street multi-use paths and trails could positively impact on how often residents walk or bike.

i. About 3 in 4 respondents somewhat or strongly agreed they would walk more if there were more street lighting after dark or if there were more off-street walking options such as multi-use trails/paths.

## b. Residents report that public transportation is less convenient than other forms.

i. When asked what might increase their use of public transportation, survey participants said that <u>time and convenience were the biggest issues</u>, with crime, cost, comfort, and child accommodations as lesser concerns.

#### G. Shirlington Circle Project Update

Through a partnership between the City, VDOT, and Arlington County, the I-395 interchange at the Shirlington Circle is being evaluated through an Operational and Safety Analysis Report (OSAR) to advance the 2020 preferred recommendation from the I-395 Shirlington Interchange Improvements Study. The OSAR documentation will include potential design and operational improvements and understand the impact to the surrounding transportation network.

Currently, conceptual designs have been developed and are being evaluated to determine the impacts to travel behavior and the operation of the network. Once more information is provided, outreach to community will be scheduled. Preliminary schedule for outreach is in the Spring. ### H. Glendale Contraflow Bicycle Lane

The City of Alexandria recently completed installation of its first contra-flow bike lane on East Glendale Avenue between Mount Vernon Avenue and Leslie Avenue. This new contra-flow bike lane provides easy and safe access for cyclists between Del Ray and the Potomac Yard Trail.

Planning, design, and outreach for the contra-flow bike lane started in the spring of 2023 in response to community feedback and Safe Routes to School Walk Audit observations made at George Washington Middle School (GMWS) earlier that year. In addition to the contra-flow bike lane, the final design included shared-lane markings (sharrows), and new high-visibility crosswalks and ADA ramps.

City staff are currently preparing materials to inform the public about how to safely use this new cycling infrastructure. They are also coordinating with Alexandria City Public Schools and staff at GWMS to ensure that the students who bike to and from school via East Glendale Avenue are doing so safely. This bike facility completes a segment of new bicycle infrastructure called for in the Pedestrian and Bicycle chapter of the Alexandria Mobility Plan (2021).
