3. DISCUSSION ITEM: Electric Vehicle Planning

ISSUE: Staff from the Office of Climate Action to provide update and information to Transportation Commission on electric vehicles.

RECOMMENDATION: That the Commission receive this presentation.

DISCUSSION: Amy Posner, Electric Vehicle Planner, presented information on Electric Vehicle Program.

4. ACTION ITEM: Consideration of Submitting Letter to WMATA on the FY25 Budget

ISSUE: Consideration of the Washington Metropolitan Area Transit Authority (WMATA) FY25 Operating and Capital budgets.

RECOMMENATION: That the Transportation Commission submit a letter to provide feedback on the FY25 budget.

DISCUSSION: Silas Sullivan, Urban Planner II presented information on the WMATA FY25 budget.

FY 2025 Proposed Operating Budget includes revenue of \$487 million, expenses of \$2,352 million, total subsidy of \$1,769 million, and \$95 million of federal relief funding.

The FY25 operating budget gap of \$750 million is proposed to be closed by a combination of revenue increases, expense reduction techniques (such as one-time cost saving measures, wage and hiring freezes, etc.), a temporary lifting of the 3% cap on operating subsidy growth, and increased funding assistance by Compact partners.

The District of Columbia (\$200 million) and the State of Maryland (\$150 million) have publicly communicated providing additional subsidy dollars to help cover the operating budget gap. The Commonwealth has budget amendments moving through the General Assembly which would provide an additional \$130 million in assistance, which would require a 50% match by jurisdictional partners.

The proposed operating budget avoids large service and frequency cuts to Metrobus and Metrorail, increases fares by 12.5% on Metrobus, Metrorail, and MetroAccess, and increases fares by up to 25% on late nights and weekends (\$2.50 cap).

Commissioner Catherwood recommended the letter include, in the second paragraph (second sentence), that maintaining current, frequent service levels is "a /the top priority" or "key feature" for the Transportation Commission.

Motion to recommend the Transportation Commission submit a letter to WMATA during the public comment period on the FY25 Budget with the suggested changes from Commissioner

Catherwood: Commissioner Kane Second: Commissioner McManus Motion carries unanimously.

SUBJECT: AGENDA ITEM #3 – ALEXANDRIA WEST SMALL AREA PLAN UPDATE

<u>ISSUE:</u> Draft Plan recommendations and maps for the future Alexandria West Plan were recently released and the draft Plan is scheduled to be released in early Summer 2024 for community review.

RECOMMENDATION: That the Commission receive this presentation and provide feedback on the draft Plan recommendations.

BACKGROUND: In Fiscal Year 2023, City Council prioritized the Alexandria West planning process to update the long-term vision for the 1992 Alexandria West Small Area Plan and to integrate the 2012 Beauregard Small Area Plan (BSAP). The Alexandria West Plan area accounts for approximately 13% of the City's land area and 17% of the City's population. Notably, 38% of the City's market-affordable units are located within the Plan area. This planning update allows the City to address issues facing the community, such as housing vulnerability and affordability, transportation network gaps, and the need for adequate open space.

The Alexandria West planning process was officially launched in November 2022. Since then, City staff have engaged over 1,500 community members and over 30 community organizations. After a robust community listening phase, which included pop-up events, formal community meetings, and polls, staff developed and proposed draft concepts for community review at a series of forums in Fall 2023.

Staff recently released draft Plan recommendations at the March 4, 2024 community meeting, after over a year of engagement with the community. The recommendations are currently open for community feedback until March 31.

<u>DISCUSSION:</u> Staff will present an overview and timeline of the Alexandria West planning effort, with a focus on recently released transportation-related recommendations and a focus on consistency with the Alexandria Mobility Plan (AMP).

The draft recommendations cover five different topics: Land Uses, Housing, Mobility, Public Parks and Open Space, and Sustainability, Infrastructure, and Community Facilities. The draft recommendations can be found on the Alexandra West project page here. They can be viewed in the interactive story map or via PDFs on the main project page. The recommendations also include related figures and maps. All recommendations and figures and maps are also attached with this memo.

The Mobility recommendations encourage a robust transportation network that provides safe access for all users, including pedestrians, bicyclists, transit users, and drivers. The street network map includes a number of new connections, in addition to those previously proposed in the Beauregard Small Area Plan. Of note are the planned streets that are solely located within the Focus Area, an area where staff anticipates a concentration of redevelopment and growth.

The recommendations also include more guidance on an enhanced transit facility at Southern Towers and safety improvements at the intersection of Seminary Road and North Beauregard Street. Additionally, a map of mobility enhancements study areas highlights intersections and corridors in the Plan area that may warrant further evaluation for multimodal safety, access, and connectivity.

Highlights of the Mobility recommendations include the following:

- 22. Development will provide the streets, blocks, and connections as generally depicted on Figure 4 ("Street Network Map") as part of development. All new streets in the Plan area will be constructed and dedicated as public streets unless otherwise approved as part of the development review process.
- 25. Development will provide a network of bike facilities as generally depicted on Figure 6 ("Bicycle Network Map"). Development that occurs in Area 2 and Area 3, as depicted on Figure 1 ("Land Use Strategy Map"), will provide new bicycle connections that link to the network depicted on Figure 6.
- 28. When possible, the City will work with property owners to add additional bicycle connections not shown on Figure 6 to other parks and routes.
- 30. The intersection of Seminary Road and Beauregard Street will be improved to better accommodate and ensure the safety of all users as generally depicted on Figure 7 ("Enhancements to Seminary and Beauregard Intersection").
- 32. The City will explore options for improving safety and accessibility for all users on Seminary Road, generally from Mark Center Drive to Library Lane.
- 33. As part of multimodal transit enhancement, a new bus facility will be established within Neighborhood 4 at the location as generally depicted on Figure 13 ("Neighborhood 4").

The draft recommendations are consistent with the guiding principles and overarching policies of the AMP, such as promoting an equitable transportation network for all users and highlighting the need for a safe and well-connected network.






Figure 3: Building Heights Map








Figure 4: Street Network Map
