Chambers' (703.746.4123) to schedule the trial date and avoid coming to court on the specified date and then file a Uniform Pretrial Scheduling Order in Room 307.

On the date of the selection of trial date hearing. Counsel and/or pro se litigants attend the hearing in the 4th floor lobby to select a trial date.

Process: The Plaintiff or Defendant files a Term Day Praecipe with the court on or before the deadline. Refer to the Court's website > scroll to "Term Day".

Prior to selection of trial date hearing. Counsel and/or pro se litigants are encouraged to call Judges' Chambers' (703.746.4123) to schedule the trial date and avoid coming to court on the specified date and then file a Uniform Pretrial Scheduling Order in Room 307.

On the date of the Term Day hearing. Counsel and/or pro se litigants attend the hearing in the 4th floor lobby to select a trial date.
