OSTP School Year Update

Current 24-25 School Year Enrollment: 1299

Current Summer 2025 Enrollment: 932

We are currently offering Out-of-School Time Programming (OSTP) at 10 afterschool locations, including 2 specialty programs—Youth Achieving Greatness and TR Achieving Greatness—and 3 LINK Club locations, for a total of 13 programming opportunities.

The OSTP Committee is actively working on **four strategic goals** designed to align our efforts with the Division's broader Strategic Initiatives. These action items aim to enhance our internal processes and create a more seamless experience for OSTP participants and their families.

2025-26 School Year: Power-On Registration

- **Pre-registration** is available to families who qualify for federal assistance programs (free/reduced-price school meals, SNAP, and TANF).
 - o Opens: June 8
 - o Closes: June 13
 - o Families will be notified of their eligibility by email or phone starting June 18.
- General online registration opens June 25 at 9 a.m.
- In-person registration begins June 26 at 9 a.m.
- Registration—both online and in-person—will remain open until all spots are filled.

Pre-registration forms can be submitted online or in person at any neighborhood recreation center or OSTP afterschool site during regular program hours.

In alignment with the City of Alexandria's **Social Equity Initiative**, priority pre-registration is available for qualifying families to ensure equitable access to the Power-On OSTP.

Partnerships & Collaborations:

RPCA partners with ACPS, UpCycle, Momentum Collective Inc., and the Buddie Ford Nature Center to enhance OSTP Power-On afterschool programming. These organizations provide specialized programming, academic support, and enrichment activities across various sites.

Program Wrap-ups:

• The Underwater Egg Hunt at Chinquapin attracted over 150 participants. The event featured a water-based egg hunt, where participants used baskets to collect as many eggs as possible. Afterward, they exchanged their eggs for a bag of candy, with the amount based on the number of eggs collected. The event was held in four sessions, each accommodating up to 50 participants, along with additional walk-ins.



• ACPS's concluded its **Middle School Swim and Dive season** with a swim meet on April 11th at the Minnie Howard Aquatics Facility.





• The Out-of-School Time Program at Charles Houston Recreation Center had a fun-filled Spring Break. Highlights included visits from Baroody Camps, the Nature Center, and the Fire and Police Departments. Participants also enjoyed making bracelets and springthemed crafts. A clear favorite among the kids was getting the chance to spray the fire hose!



 On May 2, participants in our Out-of-School Time Program took center stage at Night of Stars 2025—an unforgettable evening that celebrated the talent, creativity, and spirit of our youth. The event drew over 400 enthusiastic attendees, filling the auditorium with energy and excitement.

The program featured powerful performances in **spoken** word, dance, song, and poetry, as students showcased their gifts with passion and confidence. From heartfelt expressions to creative brilliance, each act reflected the dedication and talent nurtured through our OSTP.

Night of Stars was not just a performance, it was a celebration of courage, community, and artistic excellence. The success of the evening is a testament to the hard work and collaboration of our participants, staff, and volunteers. Families, friends, and staff left inspired and proud, reminded of the incredible potential within our programs.





 During the month of April, Nannie J. Lee Recreation Center celebrated Autism Awareness Month. The month was filled with activities that ended with an inclusion pool party at the new Minnie Howard pool.



Program Updates:

• Community Outreach & Safe Place – The Community Cookouts are officially underway. These events serve as valuable outreach opportunities to engage residents and share information about summer camps, youth programs, Safe Place resources, city-wide services, and upcoming community events. They also aim to strengthen relationships between the community and local law enforcement.

The Community Cookouts are hosted in partnership with RPCA, the Alexandria Police Department, Alexandria Sheriff's Office, Alexandria Fire Department, DCHS, ARHA, SAPCA, and a variety of other City agencies, local businesses, and non-profit organizations.

Cookouts will take place at designated locations across the City of Alexandria from **April 29 through July 1, 2025**.

 Buddie Ford Nature Center's First Friday Bird Count was a hit last month as participants spotted a red-bellied woodpecker excavating her nest. On April 4, the group returned to hear the mother woodpecker loudly guarding her nest. Everyone is excited to see nestlings on the next visit.



- On April 22, Buddie Ford staff Arianna and Dena led a **45-minute Show and Tell program** for 110 first graders at James K. Polk Elementary. The hands-on presentation featured live animals and interactive props, keeping students engaged and curious throughout. It was a fun and enriching introduction to nature.
- Patrick Henry Recreation Center launched a Drop-In Soccer program for adults on Tuesday evenings from 6:00 PM to 9:00 PM, starting April 22, 2025. The first session saw 14 participants, showing growing interest in informal recreation.



Open to ages 16 and up, the semi-organized program is suitable for all skill levels. A staff member is present to manage the clock, track scores, and ensure fair play.

The center is using the **Meetup app** to connect local residents and expand its drop-in sports community. Games are held on the lighted field, which activates automatically at sunset.

• On March 21, William Ramsay Recreation Center hosted a Teen Appreciation Event featuring competitive games, craft making, a game truck, pizza, and a DJ spinning the latest tunes. The event was a success and signals the beginning of increased teen participation in the City of Alexandria's Teen Programs.



• On March 26, **Francis C. Hammond LINK Club** hosted a **Spring Sip n' Paint** event for youth ages 11–15. The creative session encouraged social connection in a relaxed atmosphere, filled with music, conversation, and refreshments. It promoted creative expression, mindfulness, and skill development in a supportive, inclusive environment.



• Fifth-grade girls in the Space of Her Own mentoring program are completing **end-of-year room transformations**, highlighting their art and STEM projects. These personalized spaces help each girl feel supported as she transitions to middle school.



On April 19, Mount Vernon Recreation Center hosted an Egg Hunt and Art Pop-Up event. Despite the rain, families came out for a fun-filled morning. Children ages 1–4 eagerly searched for 650 eggs and enjoyed creative arts and





crafts activities with their parents and siblings.

 On May 2, Mount Vernon Rec Center and the Mount Vernon Community School PTA co-hosted "Cinco de Mile," a community fundraiser with over 300 students joining a 1-mile run and field day. Rec staff provided support, and a DJ, bake sale, and water station added to the fun.



• On May 3, Mount Vernon Recreation Center hosted its annual **Mother's Day Spa** from 11:00am-1:00pm. Moms and daughters will come out and enjoy spa treatments, massages, and manicures.



• Track and Conditioning participants returned to spring activities at Mount Vernon Recreation Center, where children ages 7-12 trained under Coach Jason's guidance. Focused on discipline and work ethic, Coach Jason is preparing the youth for the upcoming City Track Meet on May 10th.



Special Features:

- On **April 30**, Recreation Services hosted a **Hiring Event** at the Oswald Durant Center, attracting over 130 candidates for positions like Recreation Leaders, Lifeguards, and Managers on Duty. The event featured multiple interview panels and was supported by RPCA HR, Workforce Development, and City Talent Acquisition. Our goal is to host similar events bi-annually to boost staffing for OSTP, Aquatics, and Classes & Camps.
- Chinquapin has partnered with the Seaport Foundation to teach Basic Water Safety to participants in their apprenticeship program. The program provides hands-on experience in boatbuilding, and Chinquapin's support ensures safety around water for these young apprentices.
- The Community Engagement Team received a \$60,000 NRPA Grant to develop a new mentoring program for middle school youth in West End Alexandria, aimed at engaging students showing signs of school disengagement.
- The Oswald Durant Center collaborated with UnCut to collect donations for the 2025 Citywide Formal Closet. Donations were collected through March and April, helping 75 teens find prom dresses and accessories.







Staff Updates:

- Calvin Simpson has been promoted to Regional Program Director for the Sports Section. With experience at the Charles Houston Recreation Center and Fort Belvoir's MWR, Calvin brings 12 years of sports expertise. He holds a Bachelor's in Sports Management and a Master's in Athletic Leadership.

- Jada Amoako has been promoted to Full-Time Therapeutic Recreation Leader, focusing on Citywide programming, inclusion support, OSTP, and more. Jada's expertise has revitalized operations.

The Natural Resources Division continues its seasonal efforts to manage and eradicate invasive plant species across the park system. Target species active during this time of year in Northern Virginia include Japanese honeysuckle (*Lonicera japonica*), English ivy (*Hedera helix*), garlic mustard (*Alliaria petiolata*), and multiflora rose (*Rosa multiflora*).

In April and May, the division implemented a comprehensive program of mechanical removal and selective herbicide application at several high-priority sites, including Four Mile Run, Potomac Green Park (with the support of community volunteers), Kora Kelly Park, and Angel Park. These efforts are part of a broader ecological stewardship initiative aimed at preserving native biodiversity and improving habitat health.

Additional treatment sites are being scheduled for early summer based on ecological priority and available resources.





Urban Forestry

- 1. Update of the 275th Dedication Trees from last year Residents have noticed the resurgence of these trees. Many of the trees showed severe planting shock last year during the dry weather, but we are currently reporting only ~8% die-off, which is exceptionally well for boulevard trees. Most trees look great this year and survived the winter.
- 2. Volunteer Plantings have begun Urban Forestry planted our Arbor Day Tree with the Mayor on King Street in April and Urban Forestry worked with Volunteer Alexandria, a local non-profit, for the 3rd year in a row for a special commemorative planting with Holmes Run. We encourage residents and local business groups to reach out to Urban Forestry for volunteer planting opportunities.
- 3. Tree Seedling give away is happening through at Eco-Fair, May 10th. Trees are sponsored by Urban Forestry and are being handed out by the Beautification Commission.
- 4. We are continuing to deploy free trees to private residents who have requested boulevard trees, but their boulevards do not meet the width criteria. So far, we have a couple dozen homeowners enrolled in that option.

2025 Needs Assessment Survey

Project Manager: Jose Carlos Ayala, Principal Planner

The Department of Recreation, Parks, and Cultural Activities (RPCA) has completed a review of the draft 2025 RPCA Community Needs Assessment report. The consultant is now finalizing the report based on staff feedback and working concurrently to format the final content for a user-friendly, web-based dashboard that will make the information easily accessible to decision-makers and the public. The final report will be available to the community in the fall of 2025. The insights gathered will inform future planning, investments, and policy development within RPCA.

LED Light Conversion Project

Project Manager: Bethany Znidersic, Division Chief & Matt Melkerson, T&ES

Over the past several years, the City has been working to upgrade existing park and pathway lighting in City parks to LED technology. This technology has numerous benefits including:

- More Energy Efficiency: LED lights typically use 70-80% less energy than the older lights being replaced
- Less Maintenance: LED fixtures have a lifespan of 15 years, compared to older fixtures where bulbs needed to be replaced every 2-5 years.
- Less Expense: This combination of higher energy efficiency and less maintenance results in cost savings for the City.

To date, over 420 park and pathway lights have been converted to LED in City Parks, including Ben Brenman Park, Armistead L. Boothe Park, Fort Wark Park, Chinquapin Park, and a majority of the Waterfront parks. The City anticipates completing the remaining 24 park streetlight upgrades by Fall 2025. On an annual basis, the upgrades to LED streetlights in City parks are currently saving over 215,000 kilowatt-hours of energy, which is the energy savings equivalent of powering 20 typical residential homes for an entire year.

2025 Community Matching Fund

Project Manager: Lucresha Murphy-Tate, PARKnership Manager


The Department of Recreation, Parks, and Cultural Activities (RPCA) launched the 2025 Community Matching Fund application period on April 7. The program connects local businesses and organizations with City-owned parks, gardens, trails, and recreational spaces to improve them for the entire community. The Community Matching Fund provides up to \$50,000 in financial support for projects that enhance the City's public spaces. Any community group that resides or operates in the City of Alexandria is eligible to apply for the matching fund. Their proposal must showcase the ability to enhance community strength and well-being through improvements to parks and recreation facilities. Interested groups can send proposals to RPCA up until May 26. alexandriava.gov/rpca/community-matching-fund.

Hillside Park Timber Removals and Path Installation Project Manager: Daniel Unkle, Urban Planner III The project addresses the Hillside Park Pocket Park Improvement recommendations #3, #5, and #6. This project will revitalize the hillside path by removing deteriorated timbers/asphalt and installing a new trail. Work will take place in phases, beginning with the northern section of the park—adjacent to the shopping center. In this first phase, selected timbers and asphalt will be removed, the area will be fine-graded, and a natural gravel path will be installed. The surrounding space will then be seeded with a blend of native grasses and perennials, extending the woodland meadow. These enhancements will not only improve safety and accessibility but also elevate the park's aesthetics. Construction is scheduled to begin in mid-to-late June.
