Alexandria Electoral Board Meeting Minutes

Chairman Powers called the May 22, 2025, meeting to order at 9:30 a.m. Present were the three members of the Alexandria Electoral Board (Jack Powers, Bruce A. Brown, and Tom Fulton); the Director of Elections/General Registrar (Angie Maniglia Turner) and the Elections Manager (Anthony Berardo).

Previous Minutes

Mr. Fulton moved to approve the minutes from the April 9, 2025, meeting; Mr. Brown seconded the motion, and it passed unanimously.

Electoral Board Reports

Mr. Brown informed the other members of the board that he was working on the Director of Elections/General Registrar's annual evaluation, which will be due August 1st.

Election Officers

Ms. Maniglia Turner presented the Board with additions and deletions to the list of appointed election officers. Mr. Brown moved to approve the election officer appointment list; Mr. Fulton seconded the motion, and it passed unanimously.

Election Office Report

Ms. Maniglia Turner updated the Electoral Board on the office's registration numbers, absentee statistics, campaign finance reports, legislative changes, and the department's budget. Also discussed was the Same-Day-Registration process, the "Voter Placement Audit", the annual ADA Compliance Survey that will be conducted on June 17, 2025, the future replacement of the election equipment, and updates on FOIAs/public information requests. Additionally discussed were future polling place relocations.

June 17, 2025, Primary Election Preparations

Ms. Maniglia Turner gave updates on turnout projections, early voting statistics, operation of the Beatley Library satellite location, and general election updates.

Ms. Maniglia Turner gave a report on the preparations for the relocation of Precinct 202 from George Mason School to Trinity. Conversations were had regarding the ADA ramp installation, mailing voter notices, and the facilities prohibition on campaign signage on election day. Ms. Maniglia Turner informed the board that the parties will be notified of the prohibition.

Ms. Maniglia Turner gave an update regarding the emergency relocation of Olympus Condos (Precinct 309). Ms. Maniglia Turner gave information about possible relocation sites as well as the plans for once a site was determined.

Public Comment

Member of the public, Mr. Mitchell Harris, spoke briefly to the Electoral Board regarding an issue with a vehicle. It was determined that Mr. Harris was reporting his issue to the wrong office and recommended he contact Alex311.
