

Alexandria Electoral Board Canvass Minutes

Chairman Powers called the June 18, 2025, Canvass meeting to order at 9:30 a.m. Present were the three members of the Alexandria Electoral Board (Bruce, Brown, Jack Powers, and Tom Fulton); the General Registrar (Angie Maniglia Turner); the Elections Manager Anthony Berardo; Elections Intern (Christopher Bright) and one member of the public (Judy Fisher representing the Hashmi Campaign).

The Electoral Board turned the Envelope 2s over to the Elections Manager and Elections Intern to open and begin organizing in preparation of the review of Statements of Results.

Provisional Ballot Hearing

No members of the public were present for the provisional ballot hearing. The board agreed that if any voter arrived, they would move to reopen the hearing. The board confirmed that there were 194 provisional ballots and referred them to staff for research.

Review of Statements of Results

The board reviewed the Statement of Results and Incident Reports from each precinct. Upon completion, the board turned over the paperwork to the ascertainment team.

At 12:49 p.m., Mr. Brown moved to recess the Canvass meeting until June 23, 2025, at 9:30 a.m.; Mr. Fulton seconded the motion, and it passed unanimously.

Reconvening of Canvass

On June 23, 2025, at 9:30 a.m. Chairman Powers called the Canvass back into session. Present were the three members of the Alexandria Electoral Board (Bruce Brown, Jack Powers, and Tom Fulton); the General Registrar (Angie Maniglia Turner); the Elections Manager (Anthony Berardo); Assistant Elections Manager (Gretchen Coleman); Senior Deputy Registrar (Sarah Malcolm), and the Elections Intern (Christopher Bright).

Post-Election Absentee Processing

The board reviewed the Statement of Results and Incident Report from the post-election absentee processing.

Provisional Precinct

At 9:40 a.m. the Electoral Board moved into closed session to consider whether each person who submitted a provisional vote at the election was qualified to do so. Other than appropriate staff of the Electoral Board, attendance at this meeting was permitted for the persons whose provisional votes were being considered with their legal counsel, if present, as well as one authorized representative of each political party or independent candidate, as specified in §24.2-653.01(B). No voters who cast a provisional ballot were present.

At 9:44am, Mr. Fulton made a motion to move out of closed session and certify that only public business matters lawfully exempt from open meeting requirements by Virginia Law, and only such business matters as were identified in the motion convening the closed session were heard, discussed, or considered. Mr. Brown seconded the motion, and it passed unanimously. Mr. Brown made a motion to accept and count 186 provisional ballots. Mr. Fulton seconded the motion, and it passed unanimously.

At 9:45 a.m. the Electoral Board moved into closed session to continue consideration on whether each person who submitted a provisional vote at the election was qualified to do so. Other than the appropriate staff of the Electoral Board, attendance at this meeting was permitted for the persons whose provisional votes were being considered with their legal counsel, if present, as well as one authorized representative of each political party or independent candidate, as specified in §24.2-653.01(B). No voters who cast a provisional ballot were present.

At 10:08 am, Mr. Fulton made a motion to move out of closed session and certify that only public business matters lawfully exempt from open meeting requirements by Virginia Law, and only such business matters as were identified in the motion convening the closed session were heard, discussed, or considered. Mr. Brown seconded the motion, and it passed unanimously. Mr. Fulton made a motion to not count 8 provisional ballots. Mr. Brown seconded the motion, and it passed unanimously.

Abstract of Votes

After the provisional ballots were counted, the results from the provisional precinct were included in the election results. The abstract of votes was signed by the members of the Electoral Board, and the General Registrar was directed to forward documentation to the Virginia Department of Elections.
