Good afternoon,

I am a resident of the Lynhaven neighborhood. I live at 240 Evans Lane. The addition of FlavorHive at the intersection of Montrose and Richmond Highway has created a safety concern for travel along Montrose.

Lynhaven is a small community with relatively narrow streets. While parking is always a concern in our neighborhood, the addition of the FlavorHive food truck has created a safety concern for vehicles both entering Montrose from Richmond Highway and vehicles trying to exit Montrose onto Richmond Highway. Cars parked on both sides of Montrose limit the access to just a single vehicle. I've watched a number of instances of escalating road rage as folks try to traverse this area.

I have expressed concerns during the public comment period for the SUP for the restaurant; however, with FlavorHive already utilizing the space for their food truck, comments to the SUP are useless.

Eliminating parking on the north side of Montrose from Richmond Highway to the first alley entrance (also north side) would significantly improve safety for everyone. It won't completely alleviate the problem, but it will help.

Additionally, enhanced parking enforcement - keeping vehicles from blocking alleys or parking in alleys - would have a positive impact on the quality of life for residents of the neighborhood.

For Jefferson Houston, there are many kids coming from the Braddock Road Metrostation area. They often walk or bike along the trail next to the metro from Braddock to King Street Stations. Then they leave the trail at the corner of Oronoco and Earl Street. That's a very dangerous corner with cars driving too fast and in the middle of the wide road coming from Oronoco (there is a stop sign from the Earl direction). Next the kids cross Princess (after walking down Earl). There is a crosswalk, but only on one side of the street and the cars coming from the west (from the subway line) are often too fast and drivers have bad vision due to the rising sun in the morning (sun rising in the east blinding drivers going east). I think there should be a stop sign for traffic on Princess when crossing Earl.

Dear Chair and Members of the Traffic and Parking Board, I am a parent of a student at MVCS and have walked down the east side of Commonwealth across Uhler for 4 years now. I recommend voting against the parking proposal as it currently stands.

My recommendation is to vote no. Spend a week observing the situation, asking parents, and develop a new plan that eliminates or constrains parking on the south side of Uhler. That will provide a Safe Route for these kids to get to school.

Safe Routes to School are incredibly important. On my walks to school, I have observed one bus/car accident (at the east side of the Uhler/Commonwealth intersection), countless parents/caregivers, contractors, even police parking in the crosswalks across Commonwealth at Del Ray Ave and across Uhler at Commonwealth. I have politely asked people to move. I have put in numerous 311s for those who refused. I bring this up to say that I am keen aware of ensuring that MVCS kids get safely to their destination and can efficiently and safely get across streets using crosswalks. The new pole barriers on either side of the crosswalk at Commonwealth have been a huge step in the right direction.

What is a huge step in the right direction for the Uhler/Commonwealth intersection? I can only speak to the east side of the street, but my recommendation is to remove the parking on the south side (or limit hours), just after you turn off of Commonwealth onto Uhler. The issue is not the parking on Commonwealth. It is the parking on Uhler, south side, after you turn right off Commonwealth. It constricts the 2-way traffic and is an insanely busy intersection during the 730-8am half hour. People can't see, they can't turn, and they just sit and sometimes even park(!) in that intersection.

My recommendation is to vote no. Spend a week observing the situation, asking parents, and develop a new plan that eliminates or constrains parking on the south side of Uhler. That will provide a Safe Route for these kids to get to school.

Hi there,

I'm reaching out about the proposed traffic calming measures around Mount Vernon Community School. For all crossings, including the existing ones, please please have the walk sign appear automatically/in sync with the light cycle vs. only after someone presses the crosswalk button. Almost every pedestrian, especially those with children, don't get to hit the button in time for the light cycle they are in and so end up waiting another light cycle before crossing the street. This leads to confusion, pedestrian traffic build up, and unsafe crossings. I live on Mt. Ida, so I'm most familiar with the traffic at the crosswalk by the school and library (Mt. Ida/Commonwealth), and this is a constant issue. It would be so much safer if the walk symbol would appear with each light cycle. My guess is that this would also prevent needing a pedestrian exclusive phase of the light cycles, which drivers will appreciate, because it's already quite a long light when red. That being said, a pedestrian exclusive phase may make sense during school start and end, as that's when there is the most foot traffic.

Dear Mr. Hayes,

Thank you for providing the Crossing Improvements Near Schools Project information slated for the Traffic and Parking Board hearing on 7/28/2025. The DRCA Traffic Calming Committee (TCC) evaluated the project as it relates to the three intersections noted for the Mount Vernon Community School, and reached out to DRCA members as soon as the information was received on 7/22/2025. A meeting was held on 7/23/2025 for those who could attend.

While we did not have sufficient time for a full membership vote on this proposal, the TCC voted unanimously to support the proposed crosswalks and curb extensions. That said, the following concerns were raised:

- Given ongoing challenges with parking enforcement in this area, it is critical that any parking spaces being removed are, in fact, filled with the proposed curb extensions (or other appropriate daylighting amenities such as bikeshare or plantings) and are therefore physically blocked from illegal use by vehicles. We believe this is your plan, but wanted to emphasize the importance as plans move forward.
- For Groves Ave specifically, residents noted frequent double parking on the east side of Commonwealth next to the Mount Vernon Recreation Center, as well as frequent U-turns in this intersection. They expressed concern that installation of a crosswalk within that traffic dynamic may make children less safe. As such, we ask the city consider other appropriate safety measures coupled with the crosswalk.

These improvements align with DRCA goals to improve safety and walkability in Del Ray. The DRCA Executive Board also supports this planned improvement and hopes it can be completed prior to the 2030 project target.

We deeply appreciate your willingness to hear our feedback and strive to provide it to the best of our ability. As one final note, in this case, we received project details just 6 days before the Traffic and Parking Board meeting. We did our best to engage the MVCS PTA for feedback as well, but as you can imagine July is an exceptionally difficult time to engage a school community. We respectfully request additional notice and thought to enabling more comprehensive community feedback in the future.

Regarding the Mount Vernon Community School crossing improvements - this is a great start but I believe is only addressing half of the area of concern. In addition to the Commonwealth Ave. side of the school, the Mount Vernon Avenue area where morning school bus drop offs/afternoon parent pick-ups occur needs addressing.

I've lived on the 2700 block of Mount Vernon Ave for the past 6 years and I've witnessed illegal vehicle activity all day, every day, with no end in sight. Specifically near the crosswalks leading to the school crossing Mount Vernon Avenue from Stewart Ave. Food delivery drivers park illegally near the crosswalk, even ON the crosswalk, daily leading to very dangerous crosswalk conditions for the busy Mount Vernon Avenue road. Despite the city's attempt to make a "loading zone only" parking area across from the school here - these delivery drivers just don't use it. If they do, they make the illegal U-turn (where signage is present stating no U-turns allowed) to do so. These drivers just do not care about the law, so the city needs to make permanent structure changes (crosswalk bump-outs/curb extensions to prevent parking) to ensure safe conditions are being met. Otherwise, I fear someone will soon be struck by a passing vehicle that does not see a pedestrian because these crosswalks are being obstructed by illegally parked vehicles. I've personally witnessed about a dozen near-misses involving children in the recent years. I'm sure many, many more have occured. Please help. I'm not an overly concerned, overzealous parent, I don't even have children. I just see a problem occuring every day that can be ended by a simple action from a Complete Streets Coordinator like yourself.

My husband and I are low vision/blind and walk to do our errands and catch the bus. We also organize a tandem biking group for low vision individuals in Alexandria. We are therefore pleased about three proposed public safety projects you will be considering next Monday.:

We especially support the King Street Access & Safety at Alexandria City High School (T&PB Docket Item #7 because we ride our tandems down King street on most Tuesdays.): In particular, we support the protected bike lanes extended to Radford Street and the high visibility crosswalks, making it easier to cross King Street. These changes are needed to improve safety for all road users and provide safe walking and bicycling access along a high priority corridor.

We also support the 200 Block of King Street Permanent Closure (T&PB Docket Item #8): It is fun to walk that extra block with no traffic and to sample the outside seating that is made available through this change. We support this becoming permanent.

Safe Routes to School Crossing Improvements Near Schools (T&PB Docket Item #6): Unsafe vehicle speeds and unsafe crossings are the top reasons parents have cited for not allowing their children to walk or bike to school. We have several friends that teach students to ride bicycles and this is pointless without safe streets and intersections. City staff is proposing changes at intersections near four schools for (1) safer vehicle speeds, (2) shorter crossing distances and (3) better visibility by removing parking spaces immediately adjacent to applicable intersections. We support this idea.

Grassroots Alexandria (GrA) supports safer walking and biking to schools and making permanent the current "pedestrian plaza" pilot project on the 200 block of King Street.

Safe Routes to School Crossing Improvements Near Schools (T&PB Docket Item #6): Unsafe vehicle speeds and unsafe crossings are the top reasons parents have cited for not allowing their children to walk or bike to school. Excessive vehicle speeds also increase the likelihood of a fatal crash. GrA strongly supports proposed changes near four schools for (1) safer vehicle speeds, (2) shorter crossing distances and (3) better visibility by removing parking spaces immediately adjacent to applicable intersections.

King Street near ACHS lacks essential elements of a safe and equitable multi-modal corridor: pedestrian refuge islands, traffic signals timed to provide safety for people walking, connected and protected bicycle lanes, and safe and accessible bus stops. GrA strongly supports proposed safety changes on King Street at Alexandria City High School, including (1) motor vehicle lane reductions (2) a high visibility crosswalk with a pedestrian island (3) protected bike lanes (4) traffic signal changes to allow people more time to cross the street and (5) a dedicated bus pull-off. These changes will improve safety for all road users and provide safe walking, bicycling and bus access in a high priority multi-modal corridor.

Keep the 200 Block of King Street Permanently Open to People (a.k.a 200 Block of King Street Permanent Closure) (T&PB Docket Item #8): The 200 block of King Street is currently a pilot "pedestrian plaza", i.e., open to people walking and closed to cars. GrA asks that the T&PB recommend that the "pedestrian plaza" on the 200 block of King Street be made permanent. This long-awaited change will make lower King Street a more comfortable and enjoyable place to visit without vehicle emissions directly in our faces.
