TOPIC


Strategic Area: Prevention


HOW ARE WE DOING?

- 5.9% of US students were reported to have used e-cigarettes, with 3.5% of middle school students and 7.8% of high school students being involved.
- ACPS had formed a vaping work group to address this issue and provided seminars to inform and help to prevent further usage of vaping products.



IMPLEMENTATION

We have to enact new prevention measures because the ones already in place aren't enough. Prevention measures should be giving security more power to go into bathrooms when vape detectors go off, and don't have them do any more work besides that because more work will make it so prevention measures become tedious to them. If we don't enact new prevention measures then the issue will just continue to get worse and more and more people will become addicted and destroy their lives.



PERFORMANCE EFFORT

ACPS had formed a vaping work group to address this issue, held a seminar for Red Ribbon Week, educated lawmakers of Tobacco 21 (a law to increase age in which tobacco can be purchased), and presented to students about the dangers of substance abuse in general.

PERFORMANCE EFFECT

The percentage of ecigarette usage seems to be decreasing according to studies, most likely because of laws being put in place (Tobacco 21 for example), or simply that it is no longer considered interesting among youth. According to studies and surveys, there seems to be a positive decline in ecigarette usage in youth in the US, with a decline of 7.7% in 2023 to 5.9% in 2024.

RECOMMENDATIONS

We have to enact new prevention measures because the ones already in place aren't enough. If we don't enact new prevention measures then the issue will just continue to get worse and more and more people will become addicted and destroy their lives. Prevention measures should be giving security more power to go into bathrooms when vape detectors go off, and don't have them do any more work besides that because more work will make it so prevention measures become tedious to them. Our community needs to communicate the problems around vaping more and spread the word of the consequences of vaping during school. It really should be the schools taking responsibility for solving the problem because vaping is so widely spread throughout the school and is how a lot of people get into vaping. Them not having enough prevention measures is enabling kids to vape during school time. Parents could use more prevention measures but there's only so much they can do once they get to school and outside of school. When kids are in school it is up to the school to enact these prevention measures.
