A. Allowed:

- (1) Hearings and bench trials three hours or less.
- (2) **Jury trials for misdemeanor** appeal cases <u>three hours or less</u> if the jury trial is scheduled at least 6 weeks in advance.

B. Not Allowed on TMAD docket

- (1) **Hearings and bench trials over 2 hours.** These matters shall be scheduled for a set-date to schedule a date-certain. Counsel are encouraged to consult the Available Criminal Trial Slots List that is posted on the Court's website at www.alexandriava.gov/CircuitCourt > scroll to criminal local procedures.
- (2) Misdemeanor Appeal jury trials over 3 hours (see below).
- C. Misdemeanor Appeal Jury Trials
 - (1) 3 hours or less may be scheduled for a TMAD docket if the jury trial is scheduled at least 6 weeks in advance.
 - (2) 3 hours or more may be scheduled for a Friday at 10:00 a.m. if all of the following conditions are met: 3 witnesses maximum; evidence presentation limited to 3 hours; jury deliberations estimated to start no later than 1:00 p.m.
 - (3) **3 hours or more** (and cannot meet the above restrictions) may be scheduled for 10:00 a.m. on a date-certain. Counsel shall consult the list of available criminal trial slots that is posted on the criminal local procedures website.
