1. Call to Order and Roll Call.

2. Introduction (Read by Chair, Christopher Lewis)

The Independent Community Policing Review Board (ICPRB) was established by the Alexandria City Council via unanimously adopted Resolution 2950 on June 9, 2020, which condemned police brutality and systemic racism; reaffirmed that Black Lives Matter; and stated Council's intent to establish a community policing review board in our City. The resolution also affirmed that the City of Alexandria and all government officials have a duty to ensure the protection of all communities through actions and reform, including in the justice system. After careful consideration, at its public hearing on April 17, 2021, the City Council voted unanimously to adopt an ordinance establishing the structure of a new Independent Community Policing Review Board, to be effective as of July 1, 2021, along with its authorizing state law. The City Council also established the Office of the Alexandria Independent Policing Auditor (AIPA).

3. Board's Purpose (Read by Chair, Christoher Lewis)

The Independent Community Policing Review Board is an eight-member board whose purpose is to enhance policing legitimacy and to increase and maintain trust between and among the police department, city council, city manager and the public. The board shall provide timely, fair and objective review of administrative investigations conducted by the Independent Policing Auditor and Alexandria

Police Department (APD) as well as the Independent Policing Auditor's evaluation of policing policies, practices, procedures, and outcomes in Alexandria. The Board shall also recommend meaningful assessments and corrective recommendations intended to remedy discriminatory practices, including racial and social inequities; ensure the protection of all communities through recommended actions and reform, including in the criminal justice system; and recommend strategies for effectively implementing these reforms in our community.

4. Public Comments.

Marjoarie Leong spoke to the ICPRB members regarding mental illness and police actions.

5. Auditor Update

- ✓ The Auditor shared recent updates made to the ICPRB website and encouraged Board members to explore the site and its resources to better guide community members to relevant information.
- ✓ A reminder was given regarding mandatory training requirements. The Auditor emphasized the importance of being respectful of the time and resources provided by APD and other city staff in supporting these training efforts, as outlined in the ICPRB ordinances.
- ✓ An updated timeline regarding the ongoing in-custody death investigation was provided. Due to the fact that one Medical Examiner's office handles all CIRT cases in Virginia, there is currently an estimated three-month delay in receiving the ME report. The investigation is expected to conclude by late 2025 or early 2026. A press release will be issued to update the public on this revised timeline.
- ✓ The Auditor reminded members about the upcoming Proclamation for Kim Neal, scheduled for October 2nd at 6:00 PM at the Black History Museum.
- ✓ The Auditor informed the Board of a new city process for coordinating community engagement events, now managed through OCCE. Community walk events were discussed; however, few Board members volunteered to participate. The Auditor noted she will not conduct these walks alone and stressed the importance of member involvement in engaging directly with the communities they serve. The Chair added that it would be helpful for at least one ICPRB member to assist in planning and executing these events, as community engagement is a key Board responsibility.

6. New Board Business

Because there was no quorum, the following items could not be voted on; as such it was decided a virtual meeting later this month would be held to formally discuss and vote on them.
