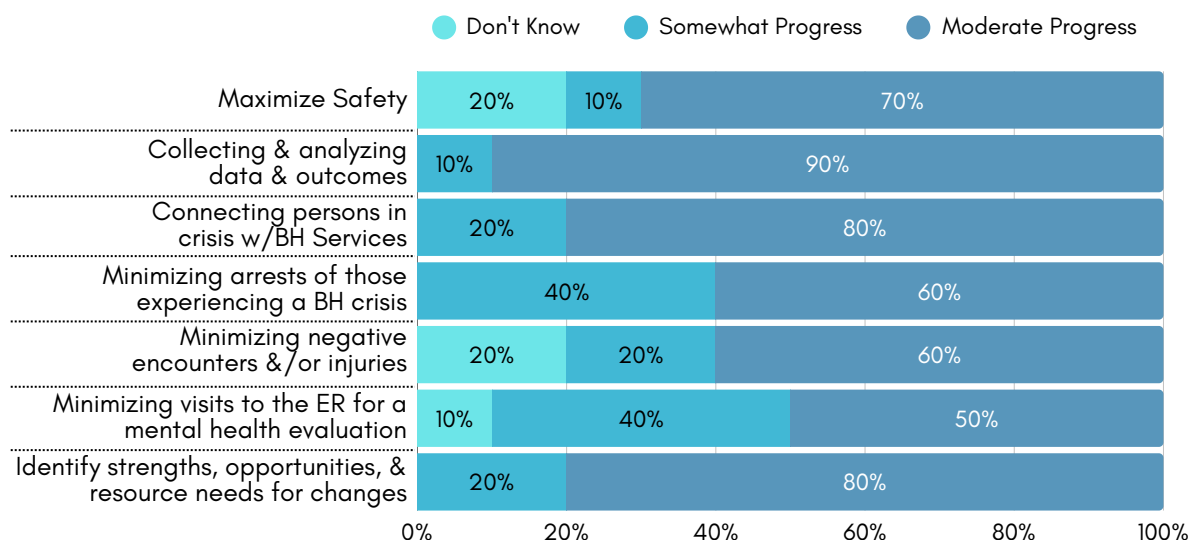

ACHS is adding extra security guards at both campuses, including new security protocols at weapon screening, more hallway monitoring, security duty stations in high traffic areas and increased lunch supervision.
