Dear Members of the Traffic and Parking Board,

I am the George Mason Elementary School PTA President, and I am writing to express concerns regarding the proposed removal of residential parking spaces at the intersection of Cameron Mills Road and Woodland Terrace.

This proposed action stems from safety concerns raised by parents and the George Mason Elementary School PTA regarding the school bus stop temporarily located at this intersection during the George Mason Elementary modernization project. Our concerns have always been focused on the safety of children: more than 50 students currently wait for the school bus along a narrow sidewalk, shared with a DASH stop, at a complex and visibility-challenging intersection.

Parents repeatedly urged ACPS Transportation to relocate and/or split this stop to alleviate crowding and improve safety. Multiple alternative, safer stop locations were suggested. Despite this, ACPS moved forward with keeping the bus stop at Cameron Mills & Woodland and requested the City install curb cuts and a crosswalk.

While I am grateful that a crosswalk and curb cuts were added to increase safety for children and pedestrians at this intersection, I believe the current design is flawed and does not effectively address the core problems. The crosswalk leads to areas without sidewalks (both the west side of Cameron Mills and North side of Woodland Terrace), forcing pedestrians into the roadway, and does not resolve the overcrowding at the bus stop. Now, as a consequence of this temporary bus stop remaining in place, the City is proposing to remove critical residential parking spaces, claiming that parked vehicles obstruct sight-lines.

This trade-off creates new safety concerns: residents will instead be pushed to park on a street with no sidewalk, forcing children to walk in the roadway and residents to unload their cars on an unsafe pass-through street - undermining the very safety goals this project is attempting to achieve.

To be clear:

• The PTA did not endorse the removal of residential parking.

- The PTA did not request a crosswalk in a location unattached to sidewalks.
- Our advocacy was specifically tied to the temporary presence of an unsafe school bus stop - not to permanent infrastructure changes that negatively impact residents and fail to solve the core safety issues.

I believe this proposal prioritizes a short-term workaround over a common-sense safety solution: **move the bus stop**. Doing so would eliminate the need for costly infrastructure modifications or parking loss. We respectfully ask the Traffic and Parking Board to:

- 1. Deny the removal of residential parking at Cameron Mills Road and Woodland Terrace; and
- 2. Recommend that ACPS Transportation re-evaluate the location of the current bus stop and relocate it to a safer location further down the street where parents have already identified feasible options.

This decision should meaningfully improve safety for children - not trade one safety hazard for another or create long-term burdens for residents over a temporary need.

Thank you for your consideration and for your continued commitment to transportation safety for all Alexandria residents. I would welcome the opportunity to speak further or provide additional information on behalf of concerned families.

Dear Ms. Orr,

I am writing to express concern and request clarification regarding the plan to remove parking in front of my home on Cameron Mills Road. While I appreciate the recent addition of the crosswalk and understand the city's commitment to improving pedestrian safety, the decision to eliminate parking in front of my property raises several important questions and concerns.

First, I would like to better understand the rationale for this change. Specifically, how does removing parking on Cameron Mills directly improve safety? From my perspective, this action does not appear to address several core safety issues at this intersection and surrounding area, including:

- The crowded and frequently unsafe conditions at the GMES bus stop,
- The absence of sidewalks on Woodland Terrace on both sides of this intersection,
- The absence of sidewalks along Woodland Terrace, and
- Ongoing congestion and speeding on Woodland Terrace, which has increasingly become a cut-through for drivers avoiding the Braddock Road intersection.

In fact, removing the parking space in front of my home may unintentionally worsen safety. I will now have to park on Woodland Terrace, a narrow and busy street, where loading and unloading my children with no sidewalk will be more difficult and potentially dangerous. The street already houses cars from the residents directly on this street and is not wide enough to support car parking on both sides, which is often necessary, and the high volume of drivers using this as a cut through. I have had my corner where the new sidewalk is run over many times as people take the turn too tight to avoid traffic coming from Braddock Road. What is the plan to solve these issues?

Additionally, I would like to understand why this particular bus stop was selected for ADA accessibility improvements given that there is currently no crosswalk across Woodland

Terrace or connecting sidewalks to support safe pedestrian movement.

I respectfully request that the Department provide:

- 1. The specific safety analysis or rationale behind the decision to remove parking on Cameron Mills,
- 2. An explanation of how this change fits into broader plans for improving safety and accessibility in this area, and
- 3. Consideration of alternative measures that could achieve safety goals without eliminating necessary residential parking.

Thank you for your attention to this matter and for your continued work to improve our community's transportation safety. I look forward to your reply and continued conversation on this matter.

My name is Brendan Kiviat and I live in the 22305 zip code, ride the 104 bus and regularly walk in the area of Cameron Mills Road and Woodland Terrace. I support removing the parking space to improve pedestrian safety and ADA accessibility at this location. I would also like t pose the following questions and concerns:

- 1. Will the crosswalk include flashing beacons or activated warning signals? This crossing serves students and is the only ADA-accessible bus stop for over 1,200 feet. Active signals would improve safety.
- 2. Should staff remove additional parking spaces for better sight lines? Daylighting—removing parking near intersections—is proven to save lives and nearly all homes in the area have dedicated driveways. I'm particularly interested in this option for Woodland Terrace on the east side of the intersection pictured in the docket where vehicles often block sightlines to higher speed traffic getting onto Cameron Mills from Braddock forcing drivers to creep into the notably weathered existing crosswalk where they block pedestrian crossings.
- 3. Does this crossing affect signal timing at Braddock Road? Can signals be coordinated to improve pedestrian safety along the corridor (Fontaine St, Davis Ave, etc.)?

Hi,

I'd like to submit a public comment on Docket #9 - Yoakum Parkway Improvement.

My wife and I live at the Tuscany apartments, on Yoakum Parkway. We strongly support the flex posts that provide bikers with a greater sense of protection from cars, and would have preferred seeing this approach taken along all of Yoakum parkway like Option 2 suggests.

We are disappointed by the high priority given to preserving the number of on-street parking on Yoakum parkway, at the inconvenience and detriment of bikers who will have to interact with merging cars into and out of parking spaces.

We also find the current amount of free on-street parking to be unnecessary and deincentivizing for the future of biking on Yoakum. Yoakum parkway is already serviced by Dash bus 35, a free bus route that runs every 10 minutes throughout the day to the shopping centers on Van dorn and the metro stop. Metrobus A28 also runs here, directly to the pentagon for commuters. Dedicating the scarce amount of public right-of-way for the free storage of personal cars is questionable, but doing so while these convenient and free public transit routes exist is just missing the mark. Free abundant parking also conflicts with the city's goal of incentivizing greener modes of transportation, such as biking or taking the bus.

We strongly believe on-street parking should be reduced to promote and build better bike lanes. If on-street parking was reduced, people would consider other modes of transportation, like the free dash bus running every 10 minutes as previously mentioned, rather than driving their cars, which would then lead to a reduction in traffic in the area, thus to less crashes and less wear-and-tear on the roads.
