**SUBJECT:** CWA DCJS VSTOP (FS26-06)

#### **Background**

On May 9, 2024, the Department of Criminal Justice Services (DCJS) contacted The Office of the Commonwealth's Attorney (CWA) to inform them that they had been selected for a comprehensive monitoring review as well as a site visit which was scheduled for June 5, 2024. The purpose of the visit was to review the following grants:

- 24-01027VW20
- 23-01027VW19
- 23-A9342VA21
- 24-A9342VA22

DCJS requested that grant documentation such as award agreements, encumbrances, reports, contract documents, invoices, etc. and all authorized personnel that worked on the grants be made available during the time of the audit. The last comprehensive monitoring review of the CWA VSTOP program occurred in FY2018. The results are summarized in Table 1 below:

#### Discussion

On June 3, 2025, DCJS contacted CWA to summarize the results of the compliance review as well as the steps for the corrective actions. DCJS informed CWA that they had until September 5, to submit the corrective action plan. DCJS determined that CWA's Victim Witness Program was in compliance for the following requirements:

- Grant documentation is managed in accordance with DCJS guidance
- Financial accounting systems track the receipt, obligation, and expenditure of funds by source. Furthermore, there are policies in place that review expenditure reimbursement requests before being submitted to DCJS

DCJS found three (3) items that were out of compliance but there was no finding issued. DCJS informed CWA that they would provide technical assistance to help bring them into compliance:

- Non-Discrimination Policy and Grievance Procedures for Program Participants
- Civil Rights Training for Authorized Officials and Grant Funded Staff
- Access to services Limited English Proficiency (LEP)

The following areas required corrective action and/or clarification:

- CWA was required to submit written assurance verifying that all staff received training from Office for Victims of Crime (OVC). CWA completed this and submitted this with the corrective action plan.
- CWA was required to update their existing conflict of interest policy to include language regarding reporting potential conflicts to DCJS. CWA completed this and submitted this with the corrective action plan.
- CWA was required to create a subsidiary policy to include specific language to notify DCJS in light of personally identifiable information (PII) breach and protocol. **CWA completed** this and submitted this with the corrective action plan.
- CWA submitted background check documentation certifying that all staff had completed background checks that determined suitability with minors. CWA completed this and submitted this with the corrective action plan.

CWA submitted their corrective action plan to DCJS on August 25, 2025. On August 26, 2025, DCJS approved the corrective action plan along with supporting documentation, which satisfied all requirements.

#### Conclusion

Based on the corrective action plan being accepted by DCJS as well our review of the documentation provided to us by CWA, we consider this review closed.
