Isolution emphasized the City's duty to protect all communities through action and stability. On April 17, 2021, the Council adopted an ordinance to create the ICPRB, we July 1, 2021, and established the Office of the Alexandria Independent Policing Auditor
3.	Board's Purpose.	
	The ICPRB is an eight-member board focused on enhancing trust and legitimacy between the police, city leadership, and the public. It reviews administrative investigations by the Independent Policing Auditor and the Alexandria Police Department, evaluates policing policies and practices, and recommends reforms to address discriminatory practices and inequities and to improve public safety.
