MINUTES

1. Call to Order and Roll Call.

Chair Christopher Lewis started the meeting at 7:00 PM.

2. Introduction (Read by Vice Chair, Alexis Stackhouse)

The Independent Community Policing Review Board (ICPRB) was established by the Alexandria City Council via unanimously adopted Resolution 2950 on June 9, 2020, which condemned police brutality and systemic racism; reaffirmed that Black Lives Matter; and stated Council's intent to establish a community policing review board in our City. The resolution also affirmed that the City of Alexandria and all government officials have a duty to ensure the protection of all communities through actions and reform, including in the justice system. After careful consideration, at its public hearing on April 17, 2021, the City Council voted unanimously to adopt an ordinance establishing the structure of a new Independent Community Policing Review Board, to be effective as of July 1, 2021, along with its authorizing state law. The City Council also established the Office of the Alexandria Independent Policing Auditor (AIPA).

3. Board's Purpose (Read by Vice Chair, Alexis Stackhouse)

The Independent Community Policing Review Board is an eight-member board whose purpose is to enhance policing legitimacy and to increase and maintain trust between and among the police department, city council, city manager and the public. The board shall provide timely, fair and objective review of administrative investigations conducted by the Independent Policing Auditor and Alexandria

Police Department (APD) as well as the Independent Policing Auditor's evaluation of policing policies, practices, procedures, and outcomes in Alexandria. The Board shall also recommend meaningful assessments and corrective recommendations intended to remedy discriminatory practices, including racial and social inequities; ensure the protection of all communities through recommended actions and reform, including in the criminal justice system; and recommend strategies for effectively implementing these reforms in our community.

4. Approval of Meeting Agenda

WHEREUPON, on motion by Member Franklin, seconded by Vice Chair Stackhouse, the Board unanimously approved the agenda. Opposed, none.

5. Approval of Minutes from October 14th, 2025.

WHEREUPON, on motion by Vice Chair Stackhouse, seconded by Member Porter, the Board unanimously approved the meeting minutes October 14th, 2025. Opposed, none.

7. Updated from Chief McGuire and Office of Professional Responsibility

Lt. John East, Commander of the Office of Professional Responsibility (OPR), addressed the ICPRB to discuss strengthening collaboration and communication moving into FY2026. He proposed establishing a standing expectation of quarterly updates to the Board, during which OPR would provide high-level summaries of applicable cases, specifically those aligned with topics referenced in the MOU, as well as use-of-force incidents. The intent of this proposal is to support transparency and create a consistent public forum for updates, questions, and discussion between APD and the ICPRB.

Chair Chris Lewis raised a question regarding how this proposal aligns with the existing MOU review process. The Auditor provided clarification, noting that the proposed quarterly updates would apply to *all* relevant cases, not just those formally submitted to AIPA, which fall under the scope of the current MOU. The Auditor further explained that OPR's willingness to publicly present case information on a recurring basis reflects an effort to broaden community insight into patterns, practices, and high-level case details beyond the traditional review process.

During discussion, one ICPRB member suggested a semi-annual schedule instead of quarterly meetings. Chair Lewis stated he would consult with Chief McGuire and the Auditor to determine an appropriate cadence. The Auditor also reminded ICPRB members that the MOU is scheduled for review at the end of the year. Member Franklin requested that it be noted for the record that she supports quarterly updates.

Chief McGuire was not in attendance at the ICPRB meeting as anticipated.

8. Old Board Business

The annual report was not available to be posted prior to the meeting. Chair Chris
Lewis requested that all ICPRB members review the version that was emailed in
advance and submit any feedback or recommendations so the report may be
finalized and brought forward for a vote at the December 2025 meeting.

Mr. Lewis provided a brief introduction (earlier in the meeting after the agenda was approved) followed by a roundtable introduction of all other ICPRB members.

Both Chair Chris Lewis and Vice Chair Alexis Stackhouse shared their insights and key takeaways from attending the Annual NACOLE Conference. Vice Chair Stackhouse also discussed opportunities for the ICPRB to collaborate with NACOLE and other oversight organizations in the region, including the potential to host regional convenings and further strengthen oversight networks.

Additional information was shared regarding NACOLE organizational memberships. Chair Lewis noted that the City funds the Auditor's NACOLE membership; however, the Auditor clarified that the existing membership is an organizational membership attributed to the Office of the Independent Policing Auditor, listing her as the representative on the organizational membership; not a personal membership.

Vice Chair Stackhouse proposed that the ICPRB obtain its own NACOLE membership, emphasizing that the current membership was never intended for the Auditor's office. Vice Chair, Stackhouse also read aloud part of an email from AIPA staff stating that purchasing a second membership for the ICPRB would be an unnecessary use of taxpayer funds. Vice Chair Stackhouse expressed concern with that position and stated that, in her view, if a membership is to be funded, it should be funded specifically for the ICPRB.

A broader discussion followed regarding the AIPA budget and how ICPRB-related expenses should be prioritized, given that the Board does not have its own independent budget.

10. Stakeholder-Basked Approaches to Strategic Leadership in policing Presentation by Cara Fishman

Dr. Cara Fishman provided a presentation to the ICPRB members on a Theory of Stakeholder-Based Approaches to Mission Statement Development and Implementation in Policing.
