

Alexandria Electoral Board Meeting Minutes

Vice Chair Fulton called the December 16, 2025, meeting to order at 9:30 a.m. Present were two members of the Alexandria Electoral Board (Bruce A. Brown, and Tom Fulton); the Director of Elections/General Registrar (Angie Maniglia Turner); and the Elections Manager (Tony Berardo). Three members of the public were also present (Tyler Lincks, Printelect; Giselle Caruso, and Jeanne O'leary). Mr. Powers arrived at 10:00 a.m.

Celebration of Service

A brief thank you celebration was held between 9:30 a.m. and 9:45 a.m. for Mr. Fulton. This celebration was to thank him for his service, as this was his last meeting as a member of the electoral board.

Previous Minutes

Mr. Fulton moved to approve the minutes from the November 5, 2025, and November 13, 2025, meetings; Mr. Brown seconded the motion, and it passed unanimously.

Electoral Board Reports

Mr. Fulton made brief comments thanking everyone involved in the election process. Mr. Brown made a brief statement regarding concerns around the costs associated with possibly having more than the originally planned two elections in 2026. Mr. Brown wanted to encourage VEBA to request the state legislature to allocate funding to municipalities to assist with the financial burden of having more than the originally planned elections.

Election Office Report

Ms. Maniglia Turner updated the Electoral Board on the office's registration numbers, campaign finance reports, proposed legislation of the General Assembly, budget, updates on FOIAs/public information requests, the post-election report for the November 2025 election, and potential polling place changes.

Relocation of City Hall Precinct

The relocation of the City Hall precinct, due to renovations at the facility, was discussed. Mr. Fulton moved to have the City Hall precinct be temporarily located at the Lyles Crouch School through the duration of the renovation. Mr. Brown seconded the motion. Mr. Brown and Mr. Powers voted in favor of the motion; Mr. Fulton voted in opposition.

Mr. Brown proposed renaming the precinct "Old Town South" for the duration of the relocation. Mr. Fulton seconded. The motion passed unanimously.

Public Comment Period

Mr. Lincks spoke to the board regarding the services Printelect offers related to by-mail voting. Ms. Caruso thanked the assembled individuals for their service to the city.
