I am delivering this message to you all with a heavy heart to express the profound grief and devastation my family continues to endure every day following the tragic death of my son, Allan Tucker II, while in the custody of the Alexandria Police Department.

No parent should ever have to bury their child under such circumstances. What makes this loss even more unbearable is knowing that Allan repeatedly pleaded to go to the hospital and was ignored. He asked for medical help, and those cries were neglected. The two officers involved demonstrated what I can only describe as inhumane. Their failure to respond with urgency, compassion, and basic human decency helped to contribute to my son his death.

It is deeply disheartening to know that Allan was in the care and control of individuals sworn to protect and serve. Law enforcement officers carry not only authority, but responsibility — a responsibility to safeguard the well-being of every individual in their custody. That responsibility was not upheld. The officers' actions, and inaction, demand accountability. This was not only a failure of judgment but a failure of humanity.


Leadership establishes the standard for departmental conduct, making it essential that Police Chief McGuire implements stronger training, better oversight, and accountability within the force to prevent future incidents of this nature. No family should have to experience this kind of preventable tragedy. The officers involved must be held accountable for their actions due to being incompetent.

In the midst of this heartbreak, I would also like to sincerely thank Ms. Kamara of the Independent Policing Auditor's Office for her professionalism, integrity, and diligence in handling the investigative findings related to Allan's death. Ms. Kamara deserves acknowledgment for upholding the highest standards of accountability and ensuring that my son's case was handled with the seriousness it deserved.

While nothing can bring Allan back, I remain committed to seeking accountability and meaningful change in his memory.

His last words before being put in the car what
are you doing I asked for help he knew that was
his last moments of life

Allan Tucker did not run from the police.
He called them.

He called because he believed someone was in his home with a gun. He was scared. He was in distress. And on the video, we hear him ask — multiple times — to go to the hospital.

He said he needed help.

So I ask plainly:

When a citizen calls 911 for help and repeatedly asks to go to the hospital, what is the protocol?

There may not have been visible blood. But there were clear signs of mental distress. The female officer repeatedly several times, “He is tripping bad.”

If she believed he was “tripping bad,” then she recognized something was wrong.

But he was cooperative.

He said he called them for help, not to be arrested.

He said he was scared.

He made sure his father was safe.

He asked that his brother be notified.

He wanted the house locked.

Does someone completely out of their mind think about those things?

Was the CRT notified? And why was it not used?

If not, were officers properly trained on when to deploy it?

When Allan asked for a Sergeant, the officer told the SGT to “sweet talk him.”

What does that mean? If officers are trained in crisis response, why describe de-escalation that way?

Then we hear the same officer say, “I didn’t come to work for this.”

For what?

For a man in crisis?

For someone asking for medical help?

Mental health calls are not inconveniences. They are part of public service.

Instead of a medical evaluation, he was told he was going to jail to “sleep it off.”

Sadly, he slept — to death.

He was transported to the detention center and left in a vehicle in the sally port. A deputy is heard saying, “Turn off your vehicle.”

Is there a written policy requiring vehicles to be turned off in the sally port?

Was carbon monoxide considered?

What is the monitoring protocol for someone left in a patrol vehicle?

Throughout the video he was yelling and kicking. At some point that stopped.

Did anyone notice? NO because they were looking at their phones.

Instead of checking to see if he calming down — or was something medically wrong?

When someone asks for medical help, but

is taken to jail instead of a hospital,

then left in conditions that may pose risk — that is not just tragic.

That is accountability.

Allan Tucker called for help.

He asked for a hospital.

He was taken to jail.

And he died in custody.

The community and the family deserves transparency answers.

Not vague responses.

Not closed-door reviews.

Transparency.
