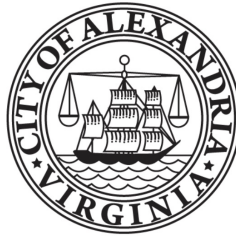

Appeal of Real Estate Assessment

The following notification is required by law and only applies to residential properties with less than four units:

Per §58.01-3331(E) of the Code of Virginia as amended and enacted by the General Assembly, effective January 1, 2012, in any appeal of assessment filed by the owner of residential real property containing less than four units to the Board of Equalization pursuant to §58.01-3379 of the Code, the assessor shall: (a) provide the property owner written notice of the hearing date at least 45 days prior to the Board hearing; (b) inform the property owner of the right to review and obtain copies of all information used in the determination of fair market value; and (c) advise the property owner of the right to request a physical inspection of the subject property.

APPEAL OF REAL ESTATE ASSESSMENT

INSTRUCTIONS FOR FILING

Be as specific as possible as to why you feel that your assessment is:

1) above or below fair market value, and/or 2) inequitable when compared to like surrounding properties.

If you are aware of specific sales which you believe are comparable to your property, or any unusual conditions that affect the fair market value, please include these with your appeal so that we may consider them in the appeal process. Sales from your property's assessment study group may be viewed on our website at alexandriava.gov/RealEstate. **Only sales occurring prior to January 1, 2026 will be considered by the Board** to determine the assessed value.

Your Appeal of Real Estate Assessment **must be typed or printed legibly on an original 2026 form** obtained from our office or downloaded from our website. Use a **separate** appeal form **for each parcel** being appealed.

Property owners, agents and/or representatives are required to submit all data that supports their reason for appeal when this form is filed.

Photographs of the property should be paper clipped to the original appeal. Do not staple any portion of your submission. All pages of your submission must be numbered consecutively.

If you are an agent for or acting on behalf of the property owner, you must provide a proper Letter of Authorization with the completed form from the property owner (not the tenant) to act on the owner's behalf for the current assessment year. You may review instructions at alexandriava.gov/real-estate/letters-of-authorization-assessment-appeals-and-reviews or request instructions from Office staff to ensure your submission of an acceptable authorization. Failure to provide a Letter of Authorization if needed will result in a denial of the application for hearing.

For commercial or income-producing properties, it is **very** important that an income and expense survey form has been filed with our Office. Failure to furnish the income and expense data precludes the owner from using this information at evidence in any proceedings under Code of Virginia §58.1-3984. Calendar year **2025** data may be submitted with your appeal, but please make sure that the information is also submitted during the yearly request for the information. A pending review by the Office or appeal to the Board of Equalization **does not change the due date for real estate taxes.**

AN ORIGINAL AND NINE COPIES OF THE COMPLETED APPEAL FORM and all supporting documentation
must be submitted together by the deadline.

Please be advised that all data supporting this appeal must be submitted when this form is filed. **NO ADDITIONAL DOCUMENTATION OF ANY KIND WILL BE ACCEPTED AT THE HEARING.** You will be advised of your **hearing date and time in writing**, and you may only **reschedule one time**. If you wish to withdraw your appeal from the Board, you must do this in writing at least forty-eight hours prior to your scheduled hearing. The Board has the authority to waive the forty-eight hour requirement, or it may hear the appeal.

All information pursuant to Virginia Code Section 58.1-3331 shall be made available to the appellant upon his/her request. Records are available for inspection and copying *by appointment* at the Office of Real Estate Assessments, Monday through Friday from noon until 4:00 p.m., except on such days when the office is otherwise closed. Any written information that will be given to the Board or relied upon by the Office regarding the 2026 assessment of your property will be available to you five (5) days prior to your hearing date.
