- Applications and supporting documents must be submitted via the City’s land use management and permitting system APEX https://apex.alexandriava.gov/EnerGov_Prod/SelfService#/home. For assistance, please contact the Boards and Commissions Unit (BCU) at planapplications@alexandriava.gov or 703.746.4666.
- Within one business day of receiving and application in APEX, staff will issue an acknowledgement receipt letter and invoice. Application fees must be paid within two business days from the date of the issued letter. Payment can be submitted online or in-person at the Department of Planning & Zoning.
- An application will be reviewed for completeness before formal acceptance by Planning & Zoning staff for a Board of Zoning Appeals Public Hearing. The applicant will be notified if the application is complete or if more information is required.
- Once the application has met all the submission requirements, staff will issue a letter of acceptance with confirmation of the scheduled hearing date and noticing instructions. The scheduled hearing date is subject to change if additional information is needed after the application has been deemed complete.
- An application package that is submitted on the deadline for submission of a complete application (second column) will be reviewed for completeness for the anticipated hearing date. In a case where an anticipated hearing date cannot be achieved due to the extent of missing information, staff will work with the applicant to determine the appropriate timing for consideration before the Board of Zoning Appeals.
- Appeals of the Director’s decision does not follow the schedule above. Appeals will be reviewed by staff for completeness and validity before it is scheduled for public hearing

*The March hearing is moved to March 16 due to a conflict with City Council’s schedule. The October hearing is moved to October 19 due to the City’s observance of Indigenous Peoples Day on October 12.
