- Applications must be submitted through [APEX](#). Once an application is received, Staff will email an acknowledgement receipt and invoice. [Application fees](#) must be paid within two business days from the date of the acknowledgement receipt. Payment can be submitted online or in person at the Department of Planning & Zoning, 421 King St, 2nd Floor, Alexandria, Va 22314.
- Applications will be reviewed for completeness before formal acceptance by Planning & Zoning. The applicant will be notified if the application is complete or if more information is required. Applicants are strongly encouraged to submit on or before the **Recommended Submission Date for Completeness Review** and work closely with staff for a better chance of having a completed application by the **Deadline for Submission of a Complete Application**. Applications that have not been deemed complete by Planning & Zoning staff by the Deadline for Submission of a Complete Application may not be considered for the desired public hearings.
- Applications will be scheduled for public hearings **only** when all the submission requirements are met, fees are paid, and Staff issues an acceptance letter. The scheduled hearing date is subject to change if additional information is required for review even if the application has been deemed complete.
