Below are the charges for the 12 individuals arrested by local police, committed to the Alexandria Adult Detention Center for local offenses, and then taken into custody by ICE after the Alexandria Sheriff's Office received lawful federal arrest warrants.

Below are the charges for the 33 individuals arrested by local police, committed to the Alexandria Adult Detention Center for local offenses, and then taken into custody by ICE after the Alexandria Sheriff's Office received lawful federal arrest warrants.

- Domestic assault and battery

Local Charges for those ICE Assumed Custody of in 2024



Below are the charges for the 43 individuals arrested by local police, committed to the Alexandria Adult Detention Center for local offenses, and then taken into custody by ICE after the Alexandria Sheriff's Office received lawful federal arrest warrants.

- Credit card fraud <\$1,000 over 6-month period, theft of credit card numbers, petit larceny less than \$1,000 not from a person
- Statutory burglary with intent to commit larceny, assault and battery, etc., possession of tools with intent to commit burglary, robbery or larceny
- Possession of schedule I or II drugs, failure to appear original charge simple assault and battery, resisting arrest, falsely identify self to law enforcement, violation of pretrial bail or conditions
- Unauthorized use of vehicle
- Community based program violation (original charge possession of drug paraphernalia)
- Possession of schedule I or II drugs (two counts)
- Sexual penetration by force, consensual intercourse with child age 15+
- Assault law enforcement officer, disorderly conduct

- Attempted robbery causing serious bodily injury, assault and battery, trespass
- Probation violation (original charge larceny >\$5 from person), larceny >\$5 from person
- Aggravated sexual battery (two counts)
- Robbery by using physical force, no serious bodily injury
- Failure to appear (original charge possession of schedule I or II drugs)
- Failure to appear (original charge resisting arrest)
- 2nd DWI within 5-10 years

Below are the charges for the 54 individuals arrested by local police, committed to the Alexandria Adult Detention Center for local offenses, and then taken into custody by ICE after the Alexandria Sheriff's Office received lawful federal arrest warrants.

- Possession of schedule I or II drugs
- Distribution of schedule I or II drugs, shoplifting <\$1,000, failure to appear (original charge shoplifting), failure to appear (two counts)
- Failure to appear original charge petit larceny less than \$1,000 not from a person
- Robbery by force, simple assault by mob
- Domestic assault and battery, contribute to the delinquency of a minor
- Robbery by using/displaying weapon (not firearm)

Local Charges for those ICE Assumed Custody of from January 1, 2026, through June 30, 2026



Below are the charges for the 23 individuals arrested by local police, committed to the Alexandria Adult Detention Center for local offenses, and then taken into custody by ICE after the Alexandria Sheriff's Office received lawful federal arrest warrants.

- Hit and run with injury or death, hit and run <\$500.
- Trespass
- Grand Larceny, two counts of petit larceny, two counts of false identify self to law enforcement
- Possession of schedule I or II drugs, possession of drug paraphernalia, drunk in public
- Probation violation (original charge grand larceny), failure to appear (original charge possession of drug paraphernalia)
- Possession with intent to distribute schedule I or II drugs, two counts of failure to appear (original charge trespass)
- Unlawful wounding
- Two counts of assault on law enforcement officer, hit and run >\$1,000.00, DWI, driving with invalid license, obstruction of justice (threat/force)
- Probation Violation (original charge domestic assault and battery)
- Two counts of aggravated sexual battery victim < 13 years of age, three counts of parent <15 sexual abuse, aggravated sexual battery: parent with child 13-17, rape by force (threat or intimidation), intercourse with victim by force (threat), indecent liberties with child by parent.
- Failure to appear (original charge possession of schedule I or II drugs), possession of schedule I or II drugs
- Petit larceny, failure to appear (original charge petit larceny)
- Malicious wounding
- Possession of a gun with schedule I or II drugs, two counts of possession with intent to distribute schedule I or II drugs, carrying a gun in public while under the influence.
- Failure to appear (original charge trespass)
- Malicious wounding
- DWI: 1st offense
- Four counts of possession with intent to distribute schedule I or II drugs
- Failure to appear (original charge failure to pay child support)
- Four counts of abuse/neglect of a child, threat in writing, attempted burglary at night to commit felony, domestic assault and battery, two counts of assault and battery, vandalism <\$1,000.00, petit larceny, driving without a license.

- Contribute to the delinquency of a minor, DWI
