### **Discussion of Open Space Finalists with Recommendation to City Council**

The Advisory Group discussed the three open space sites – Town Center, Polk/Pelham and Seminary/Echolls. Topics of discussion included functionality of the sites, timing of when sites would become available, physical characteristics, costs, connectivity of open space, the importance of placemaking, and accessibility of the site as a resource to the greater community.

During the Open Comment period of the meeting, the community provided additional comments about the strengths and weaknesses of the various sites, balancing costs, reiterated support for the previous suggestion of a linear walking trail, the importance of placemaking, and issues with

process. Ms. Sullivan with the Alexandria Night-Blooming Garden Club provided a letter of support for the Polk site from her organization.

A potential new open site at 1226 N Pegram St was suggested by the Chair, at the request of AG member Carolyn Griglione, who was not able to attend the meeting. The property, which is immediately adjacent to the proposed Polk site had recently been put on the market. After a discussion, the group opted not to include this site for consideration.

The Advisory Group agreed to recommend the Polk site to the City Council as a primary choice for the use of the Open Space funds, with the Town Center/parking lot site as the secondary choice. A draft letter was reviewed and will be finalized and sent to City Council from the AG before the next meeting.
