



Local Charges for those ICE Assumed Custody of January 1, 2018 – December 31, 2018

Below are the charges for the 121 individuals arrested by local police, committed to the Alexandria Detention Center for local offenses, and then transferred to ICE custody only after ICE filed legal detainers for them.

A review of the charges shows arrests for serious crimes, such as abduction, malicious wounding, drunk driving, burglary, and domestic assault and battery. About one-half of those arrested are non-city residents.

The asterisk (*) indicates this individual has a known criminal history in Northern Virginia that was located through a search of public records. By law, the Alexandria Sheriff's Office cannot disclose any individual's criminal history or previous ICE contacts nor can we conduct a comprehensive criminal history search for non-investigative purposes. Therefore it is possible that those without an asterisk may also have previous arrests.
