

# Alexandria Detention Center

- Office's highest concentration of staff and resources—approx. 135 of total 215 staff work in the ADC
- Opened in 1987
- Rated capacity: 343
- Avg. daily pop: 420
- Fed. inmates: 160-180
- Four floors (plus mezzanine levels)
- 15 Housing Units






# Former Inmates




