DRESS CODE

The Alexandria Juvenile and Domestic Relations District Court has adopted a dress code for court appearances. All parties before the Court are asked to dress in a respectful and appropriate manner.

The dress code **PROHIBITS:**

- Clothing with language or images that are vulgar, discriminatory, obscene, or clothing that promotes illegal or violent conduct:
 - **NO** gang symbols, unlawful use of weapons, drugs, alcohol, tobacco, or drug paraphernalia, or clothing that contains threats.
- Revealing clothing, which includes exposing cleavage, private parts, midriff, back, or undergarments:
 - **NO** sagging or low cut pants, skirts/dresses/shorts shorter than three inches above the knee, low cut necklines that show cleavage, tube tops, spaghetti straps, halter tops, backless blouses, see through garments, pajamas, and sweatpants.
- Inappropriate footwear, including but not limited to:
 - **NO** flip-flops or bedroom slippers.
- Head coverings unless required for religious or medical purposes.

This dress code has been put into place to encourage order and respect for the Court and its proceedings. All persons appearing before the Court are expected to follow the above dress code.

PERSONS FOUND IN VIOLATION OF THE DRESS CODE MAY NOT BE ALLOWED IN THE COURTROOM OR MAY BE ASKED TO CHANGE.
