

**Alexandria Electoral Board  
Minutes for March 2, 2020 meeting**

Chairman Brown called the March 2, 2020 meeting to order at 9:38 a.m. Present were the three members of the Alexandria Electoral Board (Bruce A. Brown, Jack Powers and Mary Lyman) and Angie Maniglia Turner, Elections Manager.

**Reorganization of Electoral Board**

Mr. Brown opened the floor for nominations for the election of officers of the Electoral Board, for a term ending on February 28, 2021. Ms. Lyman nominated Mr. Powers as Secretary. Mr. Brown seconded the motion and it passed unanimously. Mr. Brown nominated Ms. Lyman as Vice Chair, Mr. Powers seconded the motion and it passed unanimously. Ms. Lyman nominated Mr. Brown as Chair, Mr. Powers seconded the motion and it passed unanimously.

**Election Officer Additions and Deletions**

Ms. Maniglia Turner provided the Board with additions to the list of appointed election officers. The Board reviewed the list. Mr. Powers moved to approve the additions, Ms. Lyman seconded the motion and it passed unanimously.

**Electoral Board and Election Office Reports**

Mr. Brown moved to designate Angela Maniglia Turner as the Acting General Registrar, effective until which time Anna Leider has returned. Mr. Powers seconded the motion and it passed unanimously.

Ms. Maniglia Turner reported on a request the office received to assist in the administration of voting at the Republican Party Convention on Saturday, May 30<sup>th</sup>. Mr. Powers moved to approve the request, Ms. Lyman seconded the motion and it passed unanimously.

Ms. Maniglia Turner updated the Board on final preparations for the March 3, 2020 Democratic Party Presidential Primary Election. She briefed the board on polling places, international visitors, media contacts and the process for the canvass.
