

**Alexandria Electoral Board  
Minutes for May 14, 2020 Virtual meeting**

Chairman Brown called the May 14, 2020 virtual meeting to order at 9:30 a.m. Present were the three members of the Alexandria Electoral Board (Bruce A. Brown, Jack Powers and Mary Lyman), Anna Leider, General Registrar, Angie Maniglia Turner, Elections Manager, Casey Clark, Assistant Elections Manager and one member of the public (Holly Wallace).

**Electoral Board and Election Office Reports**

Mr. Powers moved to approve the minutes from the April 16th meeting, Ms. Lyman seconded the motion and it passed unanimously.

Ms. Leider and Ms. Maniglia Turner reported on current registered voter statistics and the Department's budget. Discussion ensued about the possible purchase of electronic pollbooks to meet the new state standards and a high-speed scanner to accommodate the increase in absentee by mail.

Ms. Leider and Ms. Maniglia Turner reported on preparations for the June 23, 2020 Republican Primary Election. Discussion ensued about the challenges associated with finding sufficient polling places, the expected turnout, and methods to hold voting safely during the COVID19 pandemic. The Board agreed that each member should visit all the polling places on June 23, 2020.

Mr. Powers, Mr. Brown and Ms. Lyman all expressed their appreciation of Anna Leider's dedication and service to the office, in regard to the notice of her retirement.




