Electoral Board Reports

Ms. Kellom asked if the office would be willing to host a group of "Take your Child to Work Day" students on April 26. Ms. Leider agreed and discussion ensued on the Take Your Child to Work Day program. Ms. Kellom also complimented Assistant Registrar Monica Alvarez on the professionalism in which she displayed prior to the meeting.

Mr. Brown reported that three candidates had qualified to be placed on the Republican Primary Ballot for U.S. Senate and that there will not be an 8th District convention as only one candidate qualified. Additionally, he asked if the office would be hosting an intern for T.C. Williams' Senior Experience program.

Election Officer Additions and Deletions

Ms. Leider provided the Board with a list of additions and deletions to the list of appointed election officers. The Board reviewed the list and Mr. Powers moved to approve the election officer additions and deletions. Ms. Kellom seconded the motion and it passed unanimously.

Election Office Report

Ms. Leider presented the Board with the minutes from the March 7th meeting. Ms. Kellom moved to approve the minutes, Mr. Powers seconded the motion and it passed unanimously.

Ms. Leider reported on the status of the review of City precinct boundaries. Mr. Brown asked the office to provide affected precincts with a list of registered voters who were moved due to the audit. Ms. Kellom expressed her appreciation of the thoroughness of the review.

Ms. Leider provided the Electoral Board with an update regarding the department's budget submission for FY 2019 as well as the FY 2018 budget projections. She also reported on legislation currently in the Virginia General Assembly and the 2020 Census. Additionally, the Board discussed the upcoming State training, preparations for the June 12, 2018 Dual Primary, and possible changes to the canvass process.

Ms. Leider reintroduced the security plan, as it was presented at the March 7th meeting. Ms. Kellom moved to approve the plan, Mr. Powers seconded the motion and it passed unanimously.


CLOSED SESSION
