





Analysis for Implementation: Transportation & Parking

- **Transportation study**

- **Based on new development and special events**
- **Access and circulation by all modes**

Parking:

- **Manage supply of on and off-street parking inventory through wayfinding, competitive pricing etc.**
- **Reduce demand by improving access for all modes**

Analysis for Implementation: Marinas and Shoreline

- **Marina siting and design considerations:**
 - **Floating/fixed docks, anchoring systems, width and length**
 - **Navigation considerations, including protection for berths and conflict avoidance**
 - **Utilities and amenities – requirements and locations**
 - **Access considerations, including ramps**
 - **Marina security and public safety**
- **Shoreline considerations:**
 - **RPA, flooding, sea level rise**
 - **Shoreline stabilization alternatives**

Analysis for Implementation: Economics & Financing

- **Economic Viability:**
 - Will the proposed uses be successful on their own?
 - Will they strengthen existing uses?
- **Financial Sustainability:**
 - Plan for operational efficiency
 - To what extent will revenues support improvements, ongoing operations?
 - Other potential funding options
 - Event spaces and rentals
 - Kiosks, carts, and other vendors or concessions
 - Public/private partnerships
- **Phasing and management**

Special emphasis areas: history, art, marinas, and parking

- History: eras and events, locations and structures, people and stories; celebrate through preservation, adaptive reuse, new structures, museums, historic ships, displays, interpretation.**
- Art: arts organizations, activities, public art, funding**
- Marinas: coordinate with commercial and recreational boating community**
- Parking: residents and the business community**
- Coordinate with city parking study, motorcoach task force, King Street retail implementation, flood mitigation study**
