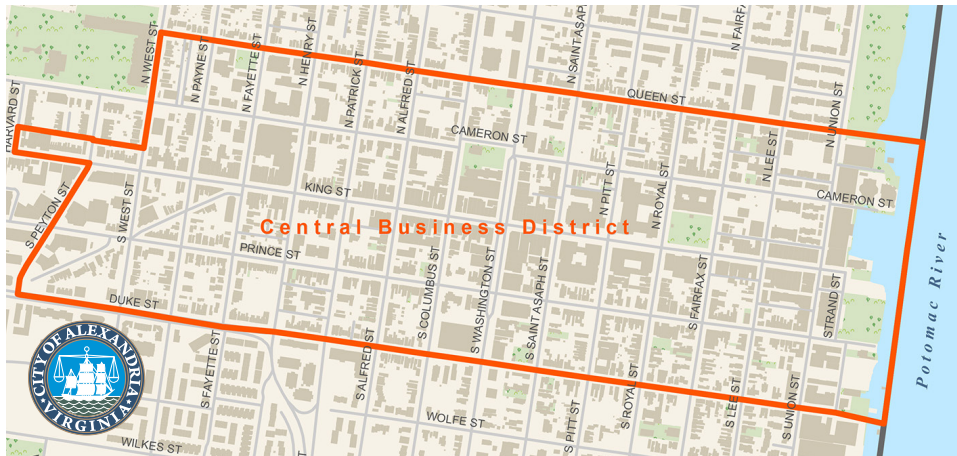


Information for Street Performers in Old Town



Street performances have been a popular attraction in Old Town Alexandria for hundreds of years, and continue to delight residents and visitors from all over the world. In order to ensure an enjoyable and peaceful experience for residents, businesses, and visitors, the Alexandria City Code includes specific regulations on the generation of sound (referred to in the law as “noise” regardless of the type). These regulations are strictest in the **Central Business District** (as shown above).

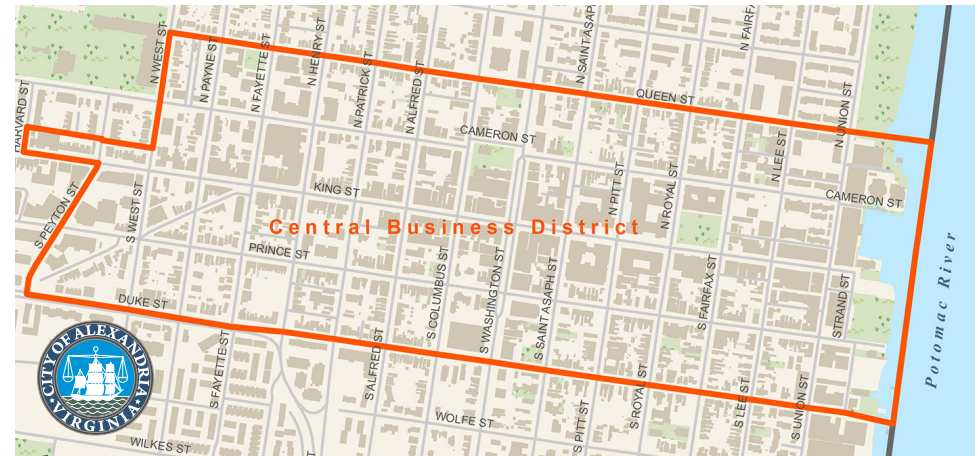
GENERAL REQUIREMENTS

- **Street performance is generally protected by the First Amendment of the U.S. Constitution.** No permit is required for the basic act of performing.
- Performers may receive donations (this is known as “busking”), but no specific charge may be suggested or required and no goods or services may be sold.

VOLUME LIMITS IN THE CENTRAL BUSINESS DISTRICT

- **The volume of a street performance, measured at a distance of 10 feet or more from the location where the sound is being produced, may not exceed 75 decibels between 7 a.m. and 11 p.m., or 65 decibels between 11 p.m. and 7 a.m.** [Sec. 11-5-4.1(c,d)]
- If a person with normal hearing can plainly hear a performance above the background noise level at a distance of more than 50 feet from the source, the performance is presumed to exceed the decibel limits and thus violate the noise ordinances unless the performer can prove otherwise. [Sec. 11-5-4.1(c,d)]
- Performances may use amplified sound as long as they adhere to the above volume limits, except where amplified sound is prohibited by posted signage. When amplified sound is permitted, devices may not be connected to City power sources, including receptacles on City buildings or street lights.

- Permits to vary these volume limits are for the very limited circumstances outlined in Section 11-5-7 of the Alexandria City Code and do not typically apply to street performances.

LOITERING AND TRESPASSING

- **Performers should strictly observe the property rights of others.** When in doubt, a performer should ask permission from the person in charge of the property where the performance will take place, and the person in charge of any immediately adjacent business or residence.
- No person may stand in a public place in a way that obstructs a sidewalk or impedes the free movement of pedestrians, including blocking access to a business. [Secs. 5-2-16 and 13-1-24(a)]
- No person may remain in a building open to the public or the immediately adjacent property after being asked to leave by a person in charge or a police officer. [Sec. 13-1-24(e)]
- No person may enter or remain on someone else's property after being told by a person in charge not to, or in violation of a posted sign. Violation is a Class 1 misdemeanor. [Sec. 13-1-33(a)]

ENFORCEMENT

- **The Alexandria Police Department is responsible for enforcing the above described rules and regulations and will make every effort to work with performers to obtain voluntary compliance.** If voluntary compliance cannot be achieved, the police will act accordingly depending on the violation.
- If violation of the City's noise ordinances continues after verbal instructions by a police officer, the violator may be issued a written notice of violation with a civil penalty of \$50. [Sec. 11-5-12(a)]
- If a person cited with a civil violation knowingly refuses or neglects to comply, the action may constitute a Class 2 misdemeanor (a crime), and a police officer may issue a criminal summons or make an arrest.
