# Fort Ward Park and Museum Area Management Plan

## Why a Management Plan?

- ‘a Management Plan is a document of policies and provides guidance to park management’ *(Jim Spengler, City of Alexandria)*

## What Will the Management Plan Accomplish?

- Identify sustainable practice strategies for the use, protection and monitoring of changes at the site over time
- Seek to balance the management of natural, cultural and recreational resources, including the earthwork fort, archaeological resources, interments, “The Fort” community and park features
- Identify potential enhancement opportunities, interpretation of site’s African American history – ‘We’re Still Here’ trail, the recognition and demarcation of graves/cemeteries, upgrades to park facilities and recreation infrastructure, public accessibility and plantings, etc.

# Fort Ward Park and Museum Area Management Plan

## Work Completed to Date

- Ad Hoc Fort Ward Park and Museum Area Stakeholder Advisory Group (FWAG), working with City staff, has developed initial ideas for how to best manage the significant historic, natural and recreational resources of Fort Ward Park
  - FWAG's Report, Recommendations for the Management of Fort Ward Historical Park, January 2011 and updated chapters
  - FWAG's Monthly Meetings and Minutes
- Consultant led informal 'Brainstorming Sessions' for two half days in the park in June 2013
- Online Survey on City's webpage in June 2013




# Fort Ward Park and Museum Area Management Plan

## Background – Assessment

### •Strengths

- Fascinating layered history
- City interpretive programs/initiatives
- High quality museum
- Impressive physical resources
- High park visitation and use

### •Weaknesses

- Limited financial resources
- Weak regional Civil War interpretation
- Complex story - limited physical area



# Fort Ward Park and Museum Area Management Plan

## Background – Assessment

### •Threats

- Divergent visions and perspectives
- Continued reductions in funding
- Lack of public appreciation

### •Opportunities

- Potential for outdoor interpretation
- Creative use of the landscape
- Coordination with other sites
- Potential to expand audiences



## Potential Models

# Making Sites Visible: “The Fort” Community



## Best Practices Examples

- Establish protection strategies for maintaining above- and below-ground evidence of “The Fort” community
- Consider trail and interpretive options (subject of upcoming meetings)


## Tonight's Discussion Topics

- Audience: **Who** are the current and potential future visitors?
- Geography: **To what extent** is interpretation limited to within the boundaries of the park itself?
- Timeframe: **When** does the Fort Ward story begin and end? Upon what timeframes should we focus?
- Themes: **What** subjects can and should be covered in interpretation?
- Implementation: **How** will we manage and coordinate storytelling so the presentation and experience is seamless? How do we coordinate with related stories other sites?
